## SURGE KIT SWEEPSTAKES

### Sweepstakes Official Rules

The Seattle Reign FC Surge Kit Sweepstakes (the “Sweepstakes”) is sponsored by Reign FC, LLC d/b/a Seattle Reign FC (“Sponsor”). **NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.** To enter, you must meet the eligibility requirements and participate in accordance with these Official Rules. The Sweepstakes are void where prohibited or restricted by applicable law, and all applicable federal, state and local laws and regulations apply. Winners are responsible for any taxes, customs, duties and like amounts in respect of the Sweepstakes prizes. The Sponsor reserves the right to cancel, modify or suspend the Sweepstakes at any time.

#### 1. ELIGIBILITY.

Eligibility to participate in the Sweepstakes or to win a prize is limited to persons: (i) who are legal residents of the State of Washington, except those who live within a seventy-five (75) mile radius around the city limits of Portland, Oregon, that extends into the State of Washington; and (ii) who are at least eighteen (18) years of age or older on the date of entry (“Eligible Participant”). The Sweepstakes are void anywhere prohibited or restricted by law, regulation, rule, or otherwise. Any effort by an Eligible Participant to misrepresent their eligibility will be disqualified. Individuals who disregard these Official Rules are not eligible to participate or win. Directors, officers, employees, contractors, agents and licensees, or their immediate families and household members (spouse, parent, child and sibling and their respective spouses, regardless of where they reside) of Sponsor, National Women’s Soccer League, LLC (“NWSL” and collectively with Seattle Reign FC, the “NWSL Entities”) and each of their parents, affiliates, subsidiaries, and advertising and promotion agencies are not eligible to participate or win a prize.

#### 2. HOW TO ENTER.

The Sweepstakes will begin on **Thursday, February 26, 2026, at 10:00 AM PST**, and conclude on **Monday, March 9, 2026, at 12:00 PM PST** (“Sweepstakes Period”). There is one (1) method of entry. No other method(s) of entry will be accepted. Limit one (1) entry per person throughout the Sweepstakes Period. If more than one (1) entry is received from any Eligible Participant during the Sweepstakes Period, only the first entry will be included, and all subsequent entries shall be disqualified as ineligible. Eligible Participants may enter the Sweepstakes via the Sweepstakes Homepage: <https://web.witcontests.com/reignfc/sweepstakes/win/the-surge-kit-260226>. To enter, Eligible Participants must complete and submit the entry form found on the Sweepstakes Homepage during the Sweepstakes Period. Upon clicking the “Enter Now” button, Eligible Participants will receive one (1) entry into the Sweepstakes (an “Entry”). Upon submitting an Entry, Eligible Participants will become an “Entrant”. Entrants agree to be bound by these Official Rules and the decisions of Sponsor which shall be binding and final and Entrant waives any right to claim ambiguity in the Sweepstakes or these Official

Rules. Entrants must complete an Entry by using their own first and last name, email address and other contact information requested on the form. If any dispute arises as to the identity of any Entrant, the Entrant will be considered the individual to whom the Entrant's email address is assigned, as shown on the email service provider's records. If an Entrant uses a mobile phone to submit an Entry, Entrant may incur data charges from their wireless service provider, check with your wireless service provider for details on any applicable charges. Entrant is solely responsible for any such wireless charges; not all wireless carriers participate. All Entries must be received by the end of the Sweepstakes Period to be eligible.

### 3. **DRAWING.**

There will be four (4) winners (the "Winners") randomly selected at the end of the Sweepstakes Period. The random selection will be conducted by Sponsor from among all eligible entries received during the Sweepstakes Period. The decisions of Sponsor are final and binding on all matters relating to this Sweepstakes. Four (4) random drawings will be conducted at the end of the Sweepstakes Period, and the **Winners will be notified via email on or around March 9, 2026**, at Sponsor's discretion and control. Winners do not need to be present to win. Odds of winning are determined by the total number of eligible entries received.

### 4. **PRIZES.**

Each Winner will receive a prize. There will be four (4) prizes awarded for the Sweepstakes – one (1) prize per drawing. Winner will receive one (1) Reign FC jersey (the "Prize").

Winners assume sole responsibility for all costs associated with any component of the Prize not explicitly outlined above, including without limitation, all federal, state and local taxes incurred as a result of being awarded the Prize. Sponsor will furnish proof of value received or other documentation if requested by the Winner. The Prize is non-transferable and non-assignable, and with no cash or cash equivalent redemptions or substitutions, however, Sponsor may in its sole discretion substitute any item within the Prize for an item of equal value. The Approximate Retail Value ("ARV") for the Prize is **One Hundred and Seventy-Five US Dollars (\$175)**. Where applicable, Autograph has no approximate retail value. The exact value of the Prize is subject to market fluctuations.

### 5. **PRIZE CLAIM.**

The Prize must be claimed by the Winner by communicating to Sponsor via email within seventy-two (72) hours from notification. If any Winner cannot be reached and/or does not respond to the email notification by seventy-two (72) hours, is found to be ineligible, or otherwise fails to follow any terms or conditions in these Official Rules, the Sponsor may consider said Winner to have forfeited the Prize. If a Winner forfeits the Prize, a new winner will not be chosen. Claimed prizes will be awarded. Prizes will be awarded by mail from the Sponsor to the Winners. As a condition of claiming the Prize, the Winners will be required to supply Winner's name, email, date of birth, mailing address, or other identification necessary to confirm Winner's identity and will be required to execute and return a Winner Declaration and Release, and, unless otherwise prohibited by law, a Release of Publicity. If any disqualification occurs, the Prize will be forfeited, and an alternate Winner will not be selected. Refusal or return of such

documents as non-deliverable or Winner's noncompliance with these Official Rules will also result in disqualification and forfeiture of the Prize and an alternate Winner will not be selected.

## **6. DATA PRIVACY.**

Data collected by Sponsor in connection with this Sweepstakes will be used by Sponsor in accordance with the Seattle Reign FC Privacy Policy located at <https://www.reignfc.com/privacy-policy> and the NWSL Privacy Policy located at <https://www.nwslsoccer.com/privacy-policy>.

## **7. PUBLICITY.**

By submitting an Entry, each Entrant and on behalf of their heirs, successor and assignees hereby grants to Sponsor, its agents and others working on its behalf the right to use the Entrant's name, likeness, voice, and any additional audio, video or photographs taken by the Sponsor or its affiliates or representatives during the Sweepstakes for advertising and marketing purposes, including on the Sweepstakes website, without additional compensation except where prohibited by law, and further grants Sponsor the right to use Entrant contact information to contact Entrants about other Sponsor programs. Potential Winners may be required to sign and return an Affidavit of Eligibility, Liability/Publicity Release and/or rights transfer document. Failure to comply with such requests may result in forfeiture of the prize.

## **8. GENERAL RULES.**

Each Entrant in the Sweepstakes agrees to be bound by these Official Rules and the decisions of Sponsor, which shall be final, and to accept delivery of any Prize won based upon availability. In addition, each Entrant represents and warrants that all information provided in the Entry is true and accurate. Sponsor is not responsible for any printing errors in these Official Rules or otherwise in any materials available at the Sweepstakes website. Sponsor shall not be responsible for lost, late, misidentified or misdirected Entries, or telecommunication or computer hardware or software performance, errors, delays or failures. Sponsor reserves the right to disqualify any individual who tampers with the entry process or the administration of the Sweepstakes. Each Eligible Participant hereby releases, and agrees to defend, indemnify and hold harmless Sponsor, NWSL Entities, Lumen Field and Events Center, First & Goal, Inc., those working on their behalf, and each of their respective owners, officers, members, managers, directors, representatives, employees, agents, successors and assigns (collectively "Released Parties"), from any damage, injury, death, loss or other liability, either at law or equity, whether known or unknown, asserted or non-asserted, that may arise from or in any way relate to participation in this Sweepstakes or the awarding, acceptance, use or misuse of the Prize or any other substitute prize. Any and all disputes, claims, and causes of action arising out of or in connection with this Sweepstakes shall be resolved individually, without resort to any form of class action. This Sweepstakes shall be governed by, and construed in accordance with, the internal laws of the State of Washington. Any action or litigation concerning this Sweepstakes shall take place exclusively in the federal or state courts sitting in King County, Washington, and each Eligible Participant expressly consents to the jurisdiction of and venue in such courts and waives all defenses of lack of jurisdiction and inconvenient forum with respect to such courts. If any provision of these Official Rules is declared or judged illegal, unenforceable, or void by a court of competent jurisdiction, the illegal, unenforceable, or void portion of the provision will be considered stricken from these Official Rules, but the remainder of these Official Rules will continue in full force and effect within the limits permitted by

law. ANY CLAIMS, JUDGMENTS AND/OR AWARDS SHALL BE LIMITED TO THE ACTUAL OUT-OF-POCKET COSTS ASSOCIATED WITH ENTERING THIS SWEEPSTAKES. ELIGIBLE PARTICIPANT HEREBY WAIVES ANY RIGHTS OR CLAIMS TO ATTORNEY'S FEES, INDIRECT, SPECIAL, PUNITIVE, INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ELIGIBLE PARTICIPANT WHETHER FORESEEABLE OR NOT AND WHETHER BASED UPON NEGLIGENCE OR OTHERWISE.

Released Parties are not responsible for stolen, late, incomplete, illegible, misdirected, lost, damaged, delayed, undelivered, inaccurate, or garbled entries. Released Parties are not responsible for lost, interrupted or unavailable network, server, Internet Service Provider ("ISP"), website, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors or difficulties occurring in connection with the administration of the Sweepstakes, the processing of entries, or in any Sweepstakes-related materials. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by website users, tampering, hacking, or by any equipment or programming associated with or utilized in Sweepstakes. Released Parties are not responsible for injury or damage to Eligible Participant's or to any other person's computer or mobile device related to or resulting from participating in this Sweepstakes or from use of the online configurator tool.

Eligible Participants who tamper with or abuse any aspect of the Sweepstakes or online configurator tool or attempt to undermine the legitimate operation of the Sweepstakes, or intend to annoy, abuse, threaten or harass any other Eligible Participant or Sponsor's representatives, which may be a violation of criminal or civil law, or who are in violation of these Official Rules, as solely determined by Sponsor, will be disqualified and any associated entries will be void. Any attempt to deliberately damage the content or operation of this Sweepstakes is unlawful and subject to legal action by Sponsor, the other NWSL entities and/or their respective agents, including Sponsor's right to seek damages to the fullest extent permitted by law.

Sponsor reserves the right, in its sole discretion, to cancel or suspend the Sweepstakes for any reason, including the occurrence of computer viruses, bugs, unauthorized human intervention, or other causes that may corrupt the administration, security, fairness, integrity or proper operation of the Sweepstakes.
