

FINAL FOCUS SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN

ELIGIBILITY: The Final Focus Sweepstakes ("Sweepstakes") is open to legal residents who live within a seventy-five (75) mile radius of Q2 Stadium located at 10414 McKalla Place, Austin, Texas 78758 ("Stadium"), plus to the extent not included in the foregoing, the geographic area included within the corporate limits of the City of San Antonio, Texas and the City of San Marcos, Texas ("Territory") and who are at least 18 years old at the time of entry. Employees, officers, and directors (including immediate family members (spouse, parent, child, and sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Austin TeamCo LLC d/b/a Austin FC ("Austin FC" or "Sponsor"), Major League Soccer, L.L.C. ("MLS"), Soccer United Marketing, LLC ("SUM"), Pro Soccer Development, LP ("MLSNP"), and Player Development, LLC ("PDEV" and together with MLS, SUM, and MLSNP, collectively, the "MLS Entities"), SharpeVision, PLLC d/b/a SharpeVision Modern LASIK ("SharpeVision"), and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers, and advertising and promotion agencies, and any and all other companies associated with the Sweepstakes are not eligible to participate or win a Prize. This Sweepstakes is in no way sponsored, endorsed, or administered by or associated with X Corp. ("X") or Meta Platforms, Inc. ("Meta"). The Sweepstakes is subject to all applicable federal, state, and local laws, rules, and regulations. Void outside Territory, and where prohibited or restricted by law, rule, or regulation.

PRIZE: For each 2026 MLS regular-season Austin FC home match in which Austin FC scores after the 88th minute of the match, one (1) Winner will receive a certificate good for one (1) free EVO Implantable Collamer Lens (ICL) Vision Correction Procedure at a SharpeVision vision center located in the Territory (appointment subject to availability; certificate expiring December 31, 2026) ("Prize"). In the event the Winner is deemed by SharpeVision in its sole and final judgment to be ineligible for the Prize for any reason, the Winner may transfer the Prize to any individual who satisfies the eligibility requirements set forth herein.

A total of up to seventeen (17) Prizes may be awarded in connection with the following 2026 currently scheduled Austin FC home matches (i.e., one (1) potential Winner per match): February 21, March 1, March 21, April 11, April 25, May 3, May 16, July 22, August 15, August 22, September 5, September 9, September 26, October 10, October 17, October 28, and November 7. The Approximate Retail Value of the Prize is \$9,490. The Winner is fully responsible for any and all applicable federal, state, and local taxes (including income and withholding taxes). All costs and expenses associated with Prize acceptance and use not specified herein, in addition to all Prize details, are at Sponsor's sole discretion.

Winner agrees to accept the prize "as is." The Prize is non-transferable and non-assignable unless the Winner is deemed by SharpeVision in its sole and final judgment to be ineligible for the Prize, with no cash redemptions or substitutions except at Sponsor's sole and absolute discretion. Sponsor reserves the right to substitute the Prize (or portion thereof) with one of comparable or greater value, at its sole and absolute discretion.

HOW TO ENTER: The entry period for the Sweepstakes begins on **February 21, 2026 at 12:00 pm CT** and ends on **November 7, 2026 at 11:59 pm CT** ("Entry Period"). During the Entry Period, any entrant who satisfies the eligibility requirements set forth herein will be eligible to enter the Sweepstakes to win the Prize by completing the following actions:

Scan the Sweepstakes QR code which will be displayed on the main videoboard at the Stadium after Austin FC scores after the 88th minute of a home match, OR click on the Sweepstakes link on the "Promotions" page of the Austin FC website. Via the Sweepstakes link, provide your first and last name, email address, zip code, and birthdate. Other than a previous Winner of a Prize, all

entrants who enter the Sweepstakes during the Entry Period remain eligible to win a subsequent Prize during the Sweepstakes.

This is the only way to enter the Sweepstakes. No other method of entry will be accepted.

RANDOM DRAWING: Approximately two (2) business days after each 2026 MLS regular-season Austin FC home match in which Austin FC scores after the 88th minute of the match, a potential winner of the Sweepstakes for that particular match ("Winner") will be selected from among all eligible entries received by Sponsor during the Entry Period. The decision of Sponsor is final and binding on all matters relating to this Sweepstakes. Odds of winning depend on the total number of eligible entries received during the Entry Period.

NOTIFICATION: Sponsor will notify each Winner by phone and/or email. In the event that any Winner does not respond to any such notification within one (1) day of the date of issuance, a disqualification will result, the Prize will be forfeited and, at Sponsor's sole discretion and time permitting, an alternate Winner may be chosen from among all remaining eligible entries. Each Winner shall confirm eligibility, agree to these rules, and confirm Winner's first name, last name, mobile phone number, and email address. Each Winner also may be required to submit Winner's valid social security number (if applicable) and/or other identification to Sponsor and may be required to execute, have notarized, and return an Affidavit of Eligibility and Release of Liability and, unless prohibited by law, Release of Publicity, within two (2) days of date of issuance. If all required documents are not properly executed and returned within the specified period of time, a disqualification will result, the Prize will be forfeited and, at Sponsor's sole discretion and time permitting, an alternate Winner may be randomly selected from among all remaining eligible entries. Refusal or return of such documents as non-deliverable or Winner's noncompliance with these Official Rules will also result in disqualification and forfeiture of the Prize and, at Sponsor's sole discretion and time permitting, may cause an alternate Winner to be selected from among all remaining eligible entries.

Released Parties (i) make no warranty, guaranty, or representation of any kind concerning any Prize, and (ii) disclaim any implied warranty. All disputes will be resolved under Texas law via state or federal courts located in Austin, Texas without giving effect to choice-of-law or conflicted law principles (whether of the state of Texas, or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the state of Texas. Sponsor's failure to enforce any terms of these Official Rules shall not constitute a waiver of that provision.

The Sponsor and the MLS Entities, as applicable, reserve the right, in their sole discretion, to cancel or suspend the Sweepstakes for any reason, including should virus, bugs, unauthorized human intervention, or other causes corrupt the administration, security, fairness, integrity or proper operation of the Sweepstakes.
