

Battlehawks Small Business Highlight Sweepstakes

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW. VOID IN FLORIDA AND NEW YORK. AT THE TIME OF ENTRY, YOU MUST BE A LEGAL RESIDENT OF THE UNITED STATES.

1. **Sweepstakes:** Battlehawks Small Business Highlight Sweepstakes (the “Sweepstakes”).
2. **Sponsor:** This Sweepstakes is powered by Wit Labs, Inc. (“Wit”) and XFL Properties LLC d/b/a United Football League, 1 N Broadway, Suite 1010, White Plains, NY 10601 (collectively, “Sponsor”).
3. **Acknowledgement:** As a condition of participating in the Sweepstakes, you agree to be fully and unconditionally bound by these Battlehawks Small Business Highlight Sweepstakes Official Rules (“Official Rules”) and the decisions of Sponsor, whose decisions shall be final and binding in all respects, and you agree to fully and unconditionally waive any right to claim ambiguity in the Sweepstakes or the Official Rules.
4. **Sweepstakes Period:** The Sweepstakes begins at 12:00am CT on Thursday, May 7, 2026, and ends at 11:59pm CT on Tuesday, May 26, 2026 (the “Sweepstakes Period”). Central Daylight Time and Central Standard Time, as applicable, shall control for all purposes of the Sweepstakes. Sponsor’s computer shall be the official clock for purposes of the Sweepstakes.

5. **Sweepstakes Administration:** Wit, on behalf of Sponsor, performs the collection, submission or processing of Entries, as well as the overall administration of the Sweepstakes. Participant may contact Wit with any questions, comments or problems related to administration of the Sweepstakes. Wit may be reached by email at team@witcontests.com during the Sweepstakes Period.
6. **Eligibility:** The Sweepstakes is open only to individual legal residents of the United States who, at the time of entry into the Sweepstakes: (i) are at least eighteen (18) years of age, You must at all times during the Sweepstakes abide by and satisfy all requirements in these Official Rules. Employees, officers, and directors of Sponsor and each of Sponsor’s affiliates, agents,

and advertising, public relations, and promotional agencies, and members of each of the preceding's immediate families (i.e., spouses, parents, children, and siblings, and their respective spouses) and those living in the same household are not eligible to enter the Sweepstakes. Sponsor is not liable for computer or program malfunctions, nor for errors in free bet awards. The Prize cannot be substituted, assigned, or transferred by the winners; however, Sponsor reserves the right to make equivalent Prize substitutions at its discretion. Sponsor will not replace the Prize in the event it is lost or stolen. Only one (1) Prizes are available to be won in the Sweepstakes. In the event, by reason of a print or other error, more than one (1) Prizes are claimed, the winners to be awarded the Prize will be selected in accordance with the winner selection method described below from among all eligible claimants making purportedly valid claims to award the up to one (1) Prize. 14. **General Conditions:** Released Parties (as defined below) are not responsible for lost, late, incomplete, inaccurate, stolen, misdirected, undelivered, garbled, illegible or postage-due mail, entries or email; or for lost, interrupted or unavailable network, server, Internet Service Provider (ISP), Platform, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors or difficulties which may occur in connection with the administration of the Sweepstakes, the processing of entries, the announcement of the Prizes or in any Sweepstakes-related materials. All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of participants or Sponsor in connection with the drawing or award, shall be governed by, and construed in accordance with, the laws of the State of Texas, without regard to conflict of law principles. All legal proceedings arising out of or in connection with the offer of these Official Rules shall be brought solely in Arlington, Texas. By participating and/or accepting a prize, participants and/or winners expressly submit to the exclusive jurisdiction of said courts and the convenient forum therein and consent to extraterritorial service of process. If any provision of these Official Rules is deemed unenforceable for any reason, such provision shall be severable and deemed null and void, and the remainder of these Official Rules shall remain in full force and effect. 17. The Battlehawks Small Business Spotlight Presented by Verizon Business ("Program") shall be structured and conducted as a sweepstakes.
