SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

ELIGIBILITY: The 2026 Tailgate the Tito's Way Sweepstakes Presented By Tito's (the “Sweepstakes”) is open to legal residents of the United States excluding residents residing in California, Maine, and Virginia, who are at least 21 years old at the time of entry. Persons under the age of twenty-one (21) are not eligible to participate in this Sweepstakes under any circumstances. Any Entry received from a person under the age of twenty-one (21) shall be null and void and may be automatically rejected and deleted. Employees, officers, and directors (including immediate family members (spouse, parent, child and sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Cleveland Browns Football Company LLC (“Club”), the National Football League and, its member professional football clubs (collectively, the “NFL Entities”), Fifth Generation Distilled Spirits, Inc. (“Tito’s Handmade Vodka”), and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the Sweepstakes are not eligible to participate in the Sweepstakes or win a Prize. The Sweepstakes is subject to all applicable federal, state and local laws, rules and regulations. No other method(s) of entry will be accepted. **Limit one (1) entry per person, per family, per e-mail address, social media handle or Facebook login, as applicable and per household, regardless of method of entry. Multiple entries received from any person or family or e-mail**

address or household in excess of the stated limitation will be void. Entrants must be 21 years of age or older.
