Welcome to the Blues Kids Drawing Fan Wall Submission (the "Submissions"), sponsored by the St. Louis Blues ("Sponsor"). PLEASE READ THESE SUBMISSION RULES CAREFULLY BEFORE ENTERING INTO THE SUBMISSION.

THERE IS NO PURCHASE OR PAYMENT NECESSARY IN ORDER TO ENTER THE SUBMISSION. ANY PURCHASE OR PAYMENT OF ANY KIND THAT YOU MAKE WILL NOT INCREASE YOUR CHANCES OF BEING SELECTED. SUBMISSIONS ARE SUBJECT TO ALL APPLICABLE FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS, AND IS VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

This Submission is powered by Wit Labs, Inc. ("Wit") on behalf of Sponsor, and is accessible via the Wit website at <u>witcontests.com</u>, through a mobile device or computer (collectively, the "Platform"). For the avoidance of doubt, Wit provides the Platform for the Submission, but is not the sponsor for the Submission.

As a legal requirement for participating in this Submission as an entrant ("Entrant"), you ("You" or "Participant") hereby agree to be bound by these Submission Rules (the "Rules") which form a legal contract by and between You and Sponsor. - 1.1 Submission Description. If an Entrant, Participant agrees to prepare and submit certain photo, video, information, documents, audio, or other materials ("Content") for evaluation in accordance with the Rules as described herein. After submission, Entrant may or may not be notified of the use of the submission (i.e. drawings, photos, etc.). Submissions received may or may not be utilized by the Blues for media pertaining to the March 19 game and other promotional ventures that follows not limited to social media, ticketing, and other media.
- 1.2 <u>Submissions Period.</u> **Submission Start Date**: March 2, 2023, 9 a.m. CT. **Submissions End Date**: March 13, 2023, 11:59 p.m. CT. The Submission will begin on the above Start Date, and will last through the above End Date ("**Submissions Period**").
- Rules. By participating in the Submission, Entrant unconditionally accepts and agrees to comply with and abide by these Rules, waives any right to claim ambiguity in the Rules or Submissions related advertising/materials and agrees that the decisions of Sponsor with respect to the Submissions.
- 1.4 <u>Submissions Administration</u>. Wit, on behalf of Sponsor, performs the collection, submission or processing of Entrant entry forms for the Submission ("Entries") as well as the overall administration of the Submission. Entrant may contact Wit with any questions, comments or problems related to administration of the Submissions. Wit may be reached by email at team@witcontests.com during the Submission Period.

2. ELIGIBILITY.

2.1 <u>Non-eligible Entities</u>. Your Content must be on topic for the Submission, and Sponsor has full discretion in determining whether or not that holds true for your Content. Upon approval by Sponsor, you will be entered into the Submission.
- 3.2 Entrants must fully complete and submit all non-optional data requested on the online entry form to be eligible. Incomplete and/or inaccurate entries are void. All entries must include a valid email address for the Entrant.
- 3.3 ONLY ORIGINAL CONTENT IS ELIGIBLE TO PARTICIPATE IN THE SUBMISSION. Each Entrant must be the original creator of his/her submitted Content, and Sponsor reserves the right to validate that originality.
- 4. <u>No Automated Entries</u>. All automated or robotic Entries submitted by individuals or organizations will be disqualified. All Entries by Entrants must be made manually by such Entrants.
