

## HAPPY HOLIDAYS FROM THE BLUES FAN WALL CONTEST

### OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. Open only to legal residents of all fifty (50) United States and the District of Columbia, except Rhode Island. Must be EIGHTEEN (18) years of age or older by contest start date to enter. Void outside the fifty (50) United States, void in Rhode Island, and void where prohibited. Employees, agents and representatives (and their immediate families (parent, child, spouse or sibling and their respective spouses, regardless of where they reside) and those living in their same households (whether or not related) of St. Louis Blues Hockey Club, L.P. ("Blues"), Administrator (defined below), any company supplying all or a portion of the Prize, and the NHL Entities (defined below) and their respective parents, affiliates, subsidiaries and advertising and promotion agencies are not eligible to enter or win. By entering, entrant understands and agrees that their Photo and name will be posted online for judging, and may otherwise be posted online, in the Blues' sole discretion, to be viewed by members of the general public.

#### ENTRY GUIDELINES:

- Entry must be original to the entrant and any text contained in Entry must be in English.
- Entry must not (and entrants represent and warrant that it will not), violate or infringe any third-party copyright, trademark, trade dress, or other proprietary right of any entity or person (living or deceased), including but not limited to rights of privacy, publicity or portrayal in a false light.

- If an Entry includes the image or likeness of anyone other than the entrant, entrant represents and warrants that entrant has obtained permission from each such individual, that entrant agrees to provide written copies of such permission to the Blues upon request and entrant certifies that such individual has reached the age of eighteen (18).

GENERAL ENTRY CONDITIONS: Entries generated by mechanical means and entry by any means which subvert the entry process are void. All entries become the property of the Blues and will not be acknowledged or returned. Entries that are late, incomplete, copied, misdirected, mutilated, illegitimate, inaccurate, illegible, lost, damaged, or incomplete entries, and/or entries that are generated by automated means, and/or late or lost entries due to data, computer and/or glitches, are void. All required information on the entry

forms must be provided, or entry will be void. Any attempt by any to obtain more than the stated number of Entries by using multiple/different accounts, email addresses, identities, registrations, and logins, or any other methods, will void the Entries by that entrant. Normal Internet access and data/usage charges imposed by your Internet/wireless phone service provider may apply. See your Internet/wireless provider for pricing plan details. Optional information requested such as opting in to receive email or text message communications from the Blues does not improve your chances of winning. **WINNER NOTIFICATION:** Winner will be notified by e-mail ("Prize Notification").
