

BLUES SUMMER FAN WALL OFFICIAL CONTEST RULES

Welcome to the **Blues Summer Fan Wall Sweepstakes**, sponsored by the **St. Louis Blues**. **PLEASE READ THESE SWEEPSTAKES RULES CAREFULLY BEFORE ENTERING INTO THE SWEEPSTAKES.**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. Open only to legal residents of all fifty (50) United States and the District of Columbia, **except** Rhode Island. Must be eighteen (18) years of age or older by sweepstakes start date to enter. Void outside the fifty (50) United States, void in Rhode Island, and void where prohibited. Employees, agents and representatives (and their immediate families (parent, child, spouse or sibling and their respective spouses, regardless of where they reside) and those living in their same households (whether or not related) of St. Louis Blues Hockey Club, L.P. ("Blues") and the NHL Entities (defined below) and their respective parents, affiliates, subsidiaries and advertising and promotion agencies are not eligible to enter or win. The NHL Entities shall be defined as the National Hockey League, its member professional hockey clubs, NHL Enterprises, L.P., NHL Enterprises Canada, L.P., NHL Enterprises B.V., NHL Interactive CyberEnterprises, LLC, NHL Network, and each of their respective subsidiaries, affiliates, shareholders, officers, directors, agents, representatives, and employees. By participating, entrants agree to be bound by these Official Rules and the decisions of the Blues, which are binding and final on all matters relating to this sweepstakes. Sweepstakes is subject to all applicable federal, state and local laws.

This Sweepstakes is powered by Wit Labs, Inc. ("**Wit**") on behalf of Sponsor, and is accessible via the Wit website at witcontests.com, through a mobile device or computer (collectively, the "**Platform**"). For the avoidance of doubt, Wit provides the Platform for the Sweepstakes but is not the sponsor for the Sweepstakes.

As a legal requirement for participating in this Sweepstakes as an entrant ("**Entrant**"), you ("**You**" or "**Participant**") hereby agree to be bound by these Sweepstakes Rules (the "**Rules**") which form a legal contract by and between You and Sponsor. **If You do not agree and consent to these Rules, please do not enter the Sweepstakes or use the Platform.** To participate in the Sweepstakes, You must agree to the Wit [Terms of Use](#). **By creating and using a Wit account, You are further required to read and agree to the Wit [Terms of Use](#).**

1. SWEEPSTAKES.

- 1.1 Sweepstakes Description. If an Entrant, Participant agrees to prepare and submit certain information ("**Content**") in accordance with the Rules as described herein. After submission, Entrant may or may not be deemed a winner, subject to eligibility and compliance with these Rules. Prizes will be awarded for this Sweepstakes, and will be publicly displayed on the Sweepstakes Landing Page.
- 1.2 Sweepstakes Period. **Sweepstakes Start Date:** Thursday, June 5, 2025 at 8 a.m. CT. **Sweepstakes End Date:** Sunday, September 14, 2025, at 11:59 p.m. CT. The Sweepstakes will begin on the above Start Date, and will last through the above End Date ("**Sweepstakes Period**").
- 1.3 Rules. By participating in the Sweepstakes, Entrant unconditionally accepts and agrees to comply with and abide by these Rules, waives any right to claim ambiguity in the Rules or Sweepstakes related advertising/materials and agrees

that the decisions of Sponsor with respect to the Sweepstakes and any prize awards shall be final and binding in all respects.

- 1.4 Sweepstakes Administration. Wit, on behalf of Sponsor, performs the collection, submission or processing of Entrant entry forms for the Sweepstakes ("**Entries**") as well as the overall administration of the Sweepstakes. Entrant may contact Wit with any questions, comments or problems related to administration of the Sweepstakes. Wit may be reached by email at team@witcontests.com during the Sweepstakes Period.

2. ELIGIBILITY.

- 2.1 Non-eligible Entities. Sponsor, and its parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies; and each of their respective officers, directors, employees, consultants and contractors (the "**Sponsor Entities**"), are ineligible to enter or vote on the Sweepstakes or win any related prize. "**Household Members**" means those people who share the same residence as any Sponsor Entity for at least three (3) months during a given year. "**Immediate Family Members**" means parents, step-parents, legal guardians, children, step-children, siblings, step-siblings or spouses of any Sponsor Entity. Household Members and Immediate Family Members of any Sponsor Entities are also not eligible to enter or win the Sweepstakes.
- 2.2 Minor Participants. This Sweepstakes is subject to, and we comply with, all applicable laws relating to the collection of information from minors including the GDPR, CCPA, USA Children's Online Privacy Protection Act ("**COPPA**") and associated Federal Trade Commission ("**FTC**") rules. Persons under the age of 18 are not eligible to participate in this Sweepstakes without consent of a parent or guardian, and persons under the age of 13 are not eligible to participate in this Sweepstakes under any circumstances. We will immediately reject and delete any Entry received from a person under the age of 18 without consent of a parent or guardian. 3. PRIZES.

- 3.1 Prize Awarded: Once a fan submits a photo, they will automatically be placed into a random pool to possibly win the prize. One (1) winner is randomly chosen by the end of the sweepstakes, which begins on Thursday, June 5, 2025 at 8 a.m. CT and ends on Sunday, September 14, 2025, at 11:59 p.m. CT. One (1) 1st Prize winner will receive a **signed Jordan Binnington Heritage jersey**. ARV: \$500 USD each. ARV: \$500 USD. (approximate retail value of \$500 USD). The total approximate retail value for prizes associated with this sweepstakes is \$500 USD.
- 3.2 Prizes cannot be transferred, redeemed for cash or substituted by an Entrant. Sponsor reserves the right in its sole and absolute discretion to award a substitute prize of equal or greater estimated value if a prize described in these Rules is unavailable or cannot be awarded, in whole or in part, for any reason. The estimated value of the prize represents Sponsor's good faith determination. That determination is final and binding - and cannot be appealed. If the actual value of the prize turns out to be less than the estimated value, the difference will not be awarded in cash. Sponsor makes no representation or warranty concerning the

appearance, safety or performance of any prize awarded. Sponsor will not replace any lost or stolen prize items.

4. **HOW TO ENTER. Entrants may enter the Sweepstakes during the Sweepstakes Period online by visiting the Blues App and doing the following:**
 - 4.1 By successfully transmitting a completed online entry form as directed after visiting the Wit website under the Bluenatics section on the home page of the Blues App at <https://web.witcontests.com/blues/artwall/summer-blues-fan-wall-250605> (specified "**Sweepstakes Landing Page**"), you will be entered into the Sweepstakes.
 - 4.2 Entrants must fully complete and submit all non-optional data requested on the online entry form to be eligible. Incomplete and/or inaccurate entries are void. All entries must include a valid email address for the Entrant.
 - 4.3 Entrant winners will be announced after successfully submitting the online entry form, and before the end of the Sweepstakes Period.
5. No Automated Entries. All automated or robotic Entries submitted by individuals or organizations will be disqualified. All Entries by Entrants must be made manually by such Entrants. Any attempt by an Entrant to submit multiple Entries by using multiple/different email addresses, phone numbers, identities, registrations, logins or any other methods will void such Entrant's Entries, and that Entrant may be disqualified. Final eligibility for the award of any prize is subject to the eligibility verification of these Rules. All Entries must be submitted by the end of the Sweepstakes Period in order to participate. Wit's database clock will be the official timekeeper for this Sweepstakes.
6. Additional Entry. Entrants may enter once (1) per gameday but may receive up to a total of eleven (11) entries before the end of the Sweepstakes Period should they enter each sweepstakes and correctly guess all the questions.
7. Winner Notification. The Sweepstakes winner(s) will be notified by e-mail at the end of the Sweepstakes Period. Sponsor and/or Wit are not responsible for any delay or failure to receive notification for any reason, including inactive account(s), technical difficulties associated therewith, or an Entrant's failure to adequately monitor the Wit app or website. Any winner notification not responded to by the Entrant, or returned as undeliverable may result in prize forfeiture. The potential prize winner may be required to sign and return an affidavit of eligibility and release of liability, and a Publicity Release (collectively "the Prize Claim Documents"). No substitution or transfer of a prize is permitted except by Sponsor.
8. Variable Probability. Due to the variable nature of the number of prizes and Entrants in the Sweepstakes, the backend engine utilizes a dynamic probability function to determine winners, based on an expected number of eligible Entries. Therefore, the probability of winning a prize may vary throughout the course of the Sweepstakes Period. The number of prizes available and the number of eligible Entries received affect the odds of winning. Some prizes may be left unawarded at the end of the Sweepstakes Period if there are fewer eligible Entries than expected. Sponsor reserves the right to award such remaining prizes, if applicable, to eligible Entrants chosen at random.

defined in the United States Copyright Act. Participant agrees that Sponsor shall be the exclusive owner of such Content and all rights therein. Sponsor's ownership includes without limitation the rights to: i) exhibit, broadcast, use, reproduce, distribute, perform and license others to use all or any part of the Content; ii) edit or modify the Content in any manner, or combine same with any other materials; and iii) use and license third parties to use the Content and/or any portion thereof in any manner of exploitation.

10. Privacy. Personally identifiable information that is submitted by Entrant as part of this Sweepstakes will be used to administer the Sweepstakes, select and announce the winner. Participant hereby waives any claims that Participant may have or acquire against the Sponsor for libel, slander, invasion of privacy, copyright or trademark violation, moral rights, right of publicity, rights of privacy, or false light arising out of or in connection with the Sponsor's or anyone else's use of the Content. Participant agrees that this waiver of privacy rights and constitutes a valid consent to uses of any Personally Identifiable Information ("PII") as may be required under applicable data protection laws. Entrant represents and warrants to Sponsor that Entrant has all the eligibility, rights and authority as required to enter the Sweepstakes, and to grant the rights granted herein; ii) the Content does not infringe the rights of any third-party person or entity; and iii) no consent of any third-party person or entity is required for submission or release of the Content.

SPECIAL DAMAGES ARISING OUT OF THIS AGREEMENT, EVEN IF SPONSOR OR WIT HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. Sponsor and Wit further assume no responsibility or liability for:

- 13.1** any incorrect or inaccurate Entry information, or for any faulty or failed electronic data transmissions.
 - 13.2** any unauthorized access to, or theft, destruction or alteration of entries at any point in the operation of this Sweepstakes.
 - 13.3** any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, regarding any equipment, systems, networks, lines, satellites, servers, camera, computers or providers utilized in any aspect of the operation of the Sweepstakes.

Sponsor and Wit shall not have any liability to any Entrant in connection with a canceled Sweepstakes.
- 15.** These Rules shall be governed by the laws of the State of Missouri, and the parties agree to personal jurisdiction and convenient forum therein. If any provision of these Rules is deemed unenforceable, such provision shall be severable and deemed null and void, and the remainder of the Rules shall remain in full force and effect. The failure of either party to insist upon the performance of any provision herein will not be construed as a waiver of such provision.
