

10/24 Guess the Home Opener Contest Rules

These are the Official Rules for the 10/24 Guess the Home Opener ("Contest"). Your participation confirms that you meet the eligibility requirements and accept these Official Rules and the decisions of Boston Legacy Football Club LLC ("Sponsor") concerning this Contest and these Official Rules.

This Contest is open to United States residents who are 18 years of age or older at the time of the person's participation in the Contest. Employees, directors, officers, and agents of Sponsor and their immediate family or household members are not eligible to participate.

CONTEST PERIOD

This Contest begins at 5:00 PM (Eastern Time) on October 24, 2025 and ends at 12:00 PM (Eastern Time) on November 25, 2025 (the "Contest Period").

HOW TO PARTICIPATE

There is one (1) method of entry for the Contest. Limit one (1) entry per Person. No illegible, incomplete, forged, or altered entries will be accepted. Participation in the Contest constitutes an agreement to these Official Rules and constitutes a binding contract between you and Sponsor.

ODDS OF WINNING

Odds of winning will depend on the total number of eligible participants who enter during the designated time period and total number of correct answers.

If the potential winner declines or forfeits, Sponsor in its sole discretion may give the prize to the next eligible participant.
