

## BRONCOS AND SONY ELECTRONICS HOLIDAY HEADPHONES SWEEPSTAKES

### Official Rules

**1. INTRODUCTION:** Denver Broncos Team, LLC d/b/a the Denver Broncos Football Club ("Broncos" or "Sponsor") is offering a sweepstakes. **NO PURCHASE NECESSARY. A PURCHASE DOES NOT IMPROVE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED BY LAW.** THIS SWEEPSTAKES CONTAINS A BINDING ARBITRATION CLAUSE.

**2. ADMINISTRATOR:** The Sweepstakes is powered by Wit Labs, Inc. ("Administrator") on behalf of the Broncos and is accessible via the Administrator's website at [witcontests.com](http://witcontests.com) or through a mobile device or computer at <https://www.denverbroncos.com/fans/contests> (collectively, the "Platform"). For the avoidance of doubt, Administrator provides the Platform for the Sweepstakes but is not the sponsor of the Sweepstakes. By creating and using an account with Administrator, all entrants are further required to read and agree to the Administrator's [Terms of Service](#). Message or data rates may apply when using a mobile device for participating or entering the Sweepstakes.

**3. ELIGIBILITY:** Entrants to the Broncos and Sony Electronics Holiday Headphones Sweepstakes ("Sweepstakes") must be U.S. residents 18 years of age or older (19 in AL, NE). In addition, if the entrant is able to demonstrate that the costs of arbitration will be prohibitive as compared to the costs of litigation, the Sweepstakes Entities retain the right to pay as much of the entrant filing and hearing fees in connection with the arbitration as the arbitrator deems necessary to prevent the arbitration from being cost-prohibitive; and (ix) If any part of this Arbitration Provision is deemed to be invalid or otherwise unenforceable or illegal, the balance of this Arbitration Provision shall remain in effect and shall be construed in accordance with its terms as if the invalid or illegal provision were not contained herein.
