BRONCOS FORD BRONCO ENTER TO WIN SWEEPSTAKES

Official Rules

- 1. INTRODUCTION: Denver Broncos Team, LLC, d/b/a the Denver Broncos Football Club (the "Broncos") is offering a sweepstakes ("Sweepstakes") in connection with Ford Motor Company ("Ford"). Ford is acting only as a prize provider and branding partner for the Sweepstakes and is not responsible for administering or conducting the Sweepstakes in any way. Ford will not be liable to any entrant in connection with the Sweepstakes. NO PURCHASE NECESSARY. A PURCHASE DOES NOT IMPROVE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED BY LAW. - **2. ADMINISTRATOR**: The Sweepstakes is powered by Wit Labs, Inc. ("Administrator") on behalf of the Broncos and is accessible on via the Administrator's website at witcontests.com or through a mobile device or computer at https://www.denverbroncos.com/fans/contests (collectively, the "Platform"). For the avoidance of doubt, Administrator provides the Platform for the Sweepstakes but is not the sponsor of the Sweepstakes. By creating and using an account with Administrator, all entrants are further required to read and agree to the Administrator's Terms of Service.
- **3. ELIGIBILITY:** Entrants, winners, and participants must be U.S. residents 18 years of age or older and a resident of Colorado, Utah, Wyoming, Idaho or South Dakota. Employees of the Broncos, Administrator, and the NFL Entities (as defined below), and Ford, and their respective parents, subsidiaries, affiliated companies, and agents, dealers, advertising and promotional agencies, wholesale distributors and individual retail licensees and the immediate family (defined as parents, spouse, children, siblings, grandparents) of each such employees, and all those with whom such employees are domiciled, are NOT eligible.

- **5. Absolutely no entries will be accepted after the end of the Sweepstakes Period. Limit one entry per person/email address. Enter only using an e-mail address subscribed and registered in your name. In the event of a dispute as to entries submitted by multiple individuals using the same e-mail account on the same day, entry will be deemed to have been submitted by the authorized subscriber of the e-mail account used to enter the sweepstakes at the actual time of entry. The authorized e-mail account subscriber is deemed to be the natural person who is assigned an e-mail address by an Internet access provider. - **6. PRIZES/ODDS:** Odds of winning depend on number of eligible entries received. A group of five (5) finalists will be selected via a random drawing of all eligible entries on or about the Thursday immediately preceding the Denver Broncos' football team's last home game of the 2025 NFL season. An additional random drawing from among the finalists will occur on or around the date of the Denver Broncos' last home game of the NFL season to select the Grand Prize winner. Absolutely no assignment, transfer or substitution of the prize is permitted, except that the Sponsor may substitute a prize of equal or greater value. Limit one (1) prize per person.

Winner Notification: The finalists will be notified by telephone. Finalists must respond to such notification within 24 hours after notification or an alternate finalist will be selected from the remaining eligible entries. Once finalist accepts, they will be emailed information pertaining to the Grand Prize drawing.

Potential prize winners may be required to execute and return affidavits of eligibility and liability/publicity releases to the Administrator, except where prohibited by law, within three (3) days following the date of

attempted notification. Subject to verification of eligibility and compliance with the terms of these Official Rules, including verification that the winner is eighteen (18) years of age or older, the potential winner will be declared an official winner of the Sweepstakes. DISPUTES: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant, Broncos or Administrator in connection with the Sweepstakes, or any claim or dispute that has arisen or may arise between you and the Broncos and/or Administrator, shall be governed by, and construed in accordance with, the laws of the State of Colorado without giving effect to any choice of law or conflict of law rules. By participating in this Sweepstakes, each entrant agrees that: (i) any claim, dispute, or controversy (whether in contract, tort, or otherwise) arising out of, relating to, or connected in any way with the Sweepstakes or the awarding or redemption of prizes will be resolved exclusively by final and binding arbitration conducted pursuant to the AAA's Procedures for Consumer-Related Disputes in conjunction with the AAA's Commercial Arbitration Rules (if and as applicable depending on the amount in controversy); (ii) this arbitration agreement is made pursuant to a transaction governed by the Federal Arbitration Act ("FAA"), 9 U.S.C. §§ 1-16; (iii) the arbitration shall be held at the AAA regional office nearest the entrant; (iv) the arbitrator's decision shall be controlled by the terms and conditions of these Official Rules and any of the other agreements referenced herein that the applicable entrant may have entered into in connection with the Sweepstakes: (v) the arbitrator shall apply Colorado law consistent with the FAA and applicable statutes of limitations and shall honor claims of privilege recognized at law; (vi) there shall be no authority for any claims to be arbitrated on a class or representative basis: arbitration can decide only the entrant's and/or the Broncos and/or Administrator's individual claims and the arbitrator may not consolidate or join the claims of other persons or parties who may be similarly situated; (vii) the arbitrator shall not have the power to award punitive damages against any party; (viii) in the event that the administrative fees and deposits the entrant is required to pay under the AAA rules exceed \$125, and the entrant is unable to pay the additional fees and deposits, the Broncos retains the right to forward them to the AAA on the entrant's behalf, subject to ultimate allocation by the arbitrator. In addition, if the entrant is able to demonstrate that the costs of arbitration will be prohibitive as compared to the costs of litigation, the Broncos retains the right to pay as much of the entrant filing and hearing fees in connection with the arbitration as the arbitrator deems necessary to prevent the arbitration from being cost-prohibitive; and (ix) if any part of this Arbitration Provision is deemed to be invalid or otherwise unenforceable or illegal, the balance of this Arbitration Provision shall remain in effect and shall be construed in accordance with its terms as if the invalid or illegal provision were not contained herein.
