SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

ELIGIBILITY: The 2025 HELMETS SWEEPSTAKES (the “Sweepstakes”) is open to legal residents of the United States who are of legal age of majority in the jurisdiction in which they reside (and at least 18 years old) at the time of entry. Persons under the age of eighteen (18) are not eligible to participate in this Sweepstakes under any circumstances.
