

## Capitals | PWHL Takeover Tour Sweepstakes Rules

Welcome to the Capitals | PWHL Takeover Tour Sweepstakes (the “**Sweepstakes**”), sponsored by Washington Capitals (“**Sponsor**”). **PLEASE READ THESE SWEEPSTAKES RULES CAREFULLY BEFORE ENTERING INTO THE SWEEPSTAKES.**

**THERE IS NO PURCHASE OR PAYMENT NECESSARY IN ORDER TO ENTER OR WIN THE SWEEPSTAKES. ANY PURCHASE OR PAYMENT OF ANY KIND THAT YOU MAKE WILL NOT INCREASE YOUR CHANCES OF WINNING. THE SWEEPSTAKES IS SUBJECT TO ALL APPLICABLE FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS, AND IS VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

For the avoidance of doubt, Wit administers and provides the Platform for the Sweepstakes, but is not the sponsor for the Sweepstakes.

As a legal requirement for participating in this Sweepstakes as an entrant (“**Entrant**” or “**You**”) hereby agree to be bound by these Sweepstakes Rules (the “**Rules**”) which form a legal contract by and between You and Sponsor. **If You do not agree and consent to these Rules, please do not enter the Sweepstakes or use the Platform.** To participate in the Sweepstakes, You must agree to the Wit [Terms of Use](#).

- 1.1 Sweepstakes Description. Entrant agrees to prepare and submit the required entry form for the Sweepstakes (an “**Entry**,” collectively the “**Entries**”) in accordance with the Official Rules as described herein. After submission, Entrant may or may not be deemed a Winner (as defined in Section 3.1), subject to eligibility and compliance with these Rules. Prizes will be awarded for this Sweepstakes, and will be publicly displayed on the Sweepstakes Landing Page (as defined below).
- 1.2 Sweepstakes Period. **Sweepstakes Start Date:** 12/20/2025 at 12:01am ET. **Sweepstakes End Date:** 1/12/2026 at 11:59pm ET. The Sweepstakes will begin on the above Start Date, and will last through the above End Date (“**Sweepstakes Period**”).
- 1.3 Rules. By participating in the Sweepstakes, Entrant unconditionally accepts and agrees to comply with and abide by these Rules, waives any right to claim ambiguity in the Rules or Sweepstakes related advertising/materials and agrees that the decisions of Wit or Sponsor with respect to the Sweepstakes and any prize awards shall be final and binding in all respects. Sponsor reserves the right to alter the terms of these Official Rules at their discretion. Any such changes to the Official Rules will be prominently displayed and any conflicting changes to the Official Rules will be superseded by the most recent version of the Official Rules.
- 1.4 Sweepstakes Administration. Wit, on behalf of Sponsor, performs the collection, submission or processing of Entries, as well as the overall administration of the Sweepstakes. ## 2. ELIGIBILITY.

- 2.1 Eligible Entrants: Sweepstakes Territory. The Sweepstakes is limited to Washington, D.C. and parts of Maryland and Virginia within one hundred fifty miles (150) miles of the Capital One® Arena at 601 F Street NW, Washington, D.C. and located in any of the U.S. Postal Service ZIP Codes attached as Appendix 1 (“**Sweepstakes Territory**”). The

Sweepstakes is void outside the Sweepstakes Territory or where prohibited by law. Entries by persons residing outside the Sweepstakes Territory will be void and not eligible for any Prize. The Sweepstakes is open only to legal residents within the Sweepstakes Territory who are of eligible age to participate, eighteen (18) years or older. By participating, Entrants agree to be bound by these Rules and the decisions of Wit or Sponsor, which are binding and final on matters relating to this Sweepstakes. **2.2** Non-eligible Persons. There will be **one (1) Grand Prize** consisting of four (4) lower bowl tickets to see the Montréal Victoire vs. New York Sirens at Capital One Arena on Sunday, January 18th at 2 PM ET along with four passes to the exclusive autograph session post-game with select players from either the Montreal Victoire or the New York Sirens Total Approximate Retail Value of the Grand Prize is \$270. - 3.3** When indicated, Prizes may comprise tickets or passes for admission to an athletic exhibition, game, or other event ("Event"). Unless otherwise indicated, all Events for which tickets are awarded as Prizes will be held at Capital One Arena located at 601 F St. NW, Washington D.C. 20004 (the "Venue"). Travel expenses are not included in the prize. Each prize winner is solely responsible for all transportation, parking, accommodations, meals and beverages, incidental expenses and gratuities while attending the event. Any prize details not specified above will be determined by Sponsor in its sole discretion. Tickets and passes awarded as Prizes are subject to the terms and conditions set forth on those tickets and passes. Tickets and passes may not be transferred, resold or offered for resale, substituted, or redeemed except as they may expressly provide. Prize Winner and his/her guest(s) agree to comply with all applicable regulations of Venue in connection with the Prize. The operator of the Venue reserves the right to deny entry to the Venue or remove from the Venue any Prize Winner and/or any guest(s) who behave in a non-sportsmanlike, disruptive, or intoxicated manner, or with intent to annoy, abuse, threaten or harass any other person at the game, event or exhibition.

**4. HOW TO ENTER. Entrants may enter the Sweepstakes during the Sweepstakes Period online by visiting the Wit website and doing the following:**

- 4.2** Entrants must fully complete and submit all non-optional data requested on the online entry form to be eligible. Incomplete or inaccurate entries are void. All entries must include a valid email address for the Entrant.

The potential prize winner may be required to sign and return an affidavit of eligibility and release of liability, and a publicity release (collectively "**the Prize Claim Documents**").
