

## SCHEDULE RELEASE SCRATCH AND WIN SWEEPSTAKES OFFICIAL SWEEPSTAKES RULES

This Sweepstakes is powered by Wit Labs, Inc. (“Wit”) on behalf of CDL and is accessible via the Wit website at [web.witcontests.com/charge/giveaway/scratchnwin/cleveland-charge-home-opener-s-250902](http://web.witcontests.com/charge/giveaway/scratchnwin/cleveland-charge-home-opener-s-250902), through a mobile device, or computer (collectively, the “Platform”). For the avoidance of doubt, Wit provides the Platform for the Sweepstakes, but is not the sponsor for the Sweepstakes. To participate in the Sweepstakes, Entrant must agree to the Wit [Terms of Use](#). By creating and using a Wit account, Entrant is further required to read and agree to the Wit [Terms of Use](#).

**2. Sweepstakes Period:** The Sweepstakes begins on September 2, 2025 at 7:00:00 AM ET and ends on September 9, 2025 at 11:59:59 PM ET (the “Sweepstakes Period”). To qualify, entries must be received during the Sweepstakes Period. Any entries received thereafter shall be null and void, and ineligible for the Sweepstakes. CDL is not responsible for late, incomplete, or misdirected entries, nor is CDL obligated to publicly announce the Sweepstakes results.

**3. To Enter: NO PURCHASE NECESSARY TO ENTER OR WIN THE SWEEPSTAKES. **4.
