

DEVILS FLYAWAY SWEEPSTAKES PRESENTED BY UNITED

Important: Please read these Official Rules before entering this Sweepstakes (the “Sweepstakes”).
By participating in this Sweepstakes, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements below.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

Sweepstakes void where prohibited by law. Subject to applicable federal, state, and local laws. This Program is powered by Wit Labs, Inc. (“*Wit*”) on behalf of Sponsor, and is administered via the Wit platform (the “*Platform*”). For the avoidance of doubt, Wit provides the Platform for the Program, but is not the sponsor for the Program.

1. **Eligibility:** The Sweepstakes is open only to legal residents of New Jersey who are at least 18 years old (or the age of majority in their jurisdiction of residence, whichever is older) at the time of entry.

Directors, officers, members, managers, and employees of the New Jersey Devils LLC, Devils Entertainment Arena LLC, The Prudential Center, (collectively, “*DAE*” or “*Sponsor*”), United Airlines, Inc. (the “*Presenting Partner*”), the National Hockey League and its member teams, and any of their respective parent companies, affiliate companies, subsidiaries, agents, professional advisors, advertising, promotional, public relations, and fulfillment agencies, consultants, legal counsel, website providers, web masters, and immediate family members (spouses, parent, child, sibling, grandparent, and “step” child, wherever they may live) of each are not eligible to win any prize. IF YOU DO NOT MEET ANY OF THESE REQUIREMENTS, OR ANY OTHER ELIGIBILITY REQUIREMENTS IN THESE OFFICIAL RULES, YOU ARE NOT ELIGIBLE TO WIN A PRIZE. To be eligible to win a prize, entries must be completed and received by Sponsor in the manner and format designated below.

2. **Sweepstakes Period:** The Sweepstakes starts at 10:00 a.m. Eastern Time (ET) on January 19, 2026 and ends at 11:59 p.m. ET on February 13, 2026 (the “*Sweepstakes Period*”). All entries must be received during the Sweepstakes Period and meet other requirements in these Official Rules to be eligible to win a prize. Sponsor’s or its designee’s computer is the official time-keeping device for the Sweepstakes.

3. **How to Enter:** To enter, during the Sweepstakes Period visit newjerseydevils.com/flyaway and follow the instructions to enter the Sweepstakes. Upon completion of these steps, you will receive one entry into the Sweepstakes. Limit one entry per person during Sweepstakes Period. Any attempts to obtain additional entries, including through multiple or duplicate accounts will result in disqualification.

FREE METHOD OF ENTRY. In addition to entering the Sweepstakes via the above method, entrants may also enter the Sweepstakes by mailing in a 3x5 index card listing the entrant’s first name and last name to Devils Arena Entertainment LLC, 25 Lafayette Street, Newark, NJ 07102. Index cards must be received by 12:00 pm ET on February 16, 2026.

Limit one entry per person during Sweepstakes Period. For any entrants that submit an entry through the Free Method of Entry described above in addition to entering through the URL listed above, the Free Method of Entry and the entry through the URL shall count as one entry. Any attempts to obtain additional entries, including through multiple or duplicate accounts will result in disqualification.

If participating in this Sweepstakes via your mobile device (which service may only be available via select devices and participating wireless carriers and is not required to enter), you may be charged for standard data use from your mobile device according to the terms in your wireless service provider’s data plan. Normal airtime and carrier

charges and other charges may apply to data use and will be billed on your wireless device bill or deducted from your pre-paid balance. Wireless carrier rates vary, so you should contact your wireless carrier for information on your specific data plan.

4. **Identity of Entrant:** All entries must be submitted by the individual entrant. Bulk or automated entries will be disqualified (including entries made using any script, macro, bot, or promotional service). Multiple participants are not permitted to share the same email account. Any attempt to obtain additional entries through fraud or other illegitimate means will result in disqualification, at Sponsor's discretion.

In the event of a dispute about the identity of the entrant, entries will be declared made by the authorized account holder of the email address submitted with the entry. An "**authorized account holder**" means the natural person who is assigned to an e-mail address by an Internet access provider, online service provider or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. A potential winner may be required to provide Sponsor with proof that a potential winner is the authorized account holder of the account associated with the winning entry.

5. **Selection and Notification of Winner:** On or about February 18, 2026, Sponsor will first select the name of one (1) potential winner of the grand prize in a random drawing from among all eligible entries and then select two (2) potential winners of the prize in a random drawing from among all the remaining eligible entries at Sponsor's headquarters as listed in Section 16 below. The potential winners will be notified via email or phone call on or about February 18, 2026. If (i) the attempted notification is returned as undeliverable without a forwarding address or the potential winner does not respond within 24 hours of being notified by Sponsor; (ii) any required documents are not returned as specified by Sponsor, such as the Affidavit of Eligibility and Liability/Publicity Release; or (iii) if potential winner is otherwise unable to accept the prize as stated, the prize will be forfeited and may be awarded to an alternate winner. Round trip coach-class airline tickets will be offered in the form of United Airlines Entity 1 H Class round-trip coach-class airfare vouchers. Vouchers are valid for travel on United and United Express to/from the 48 contiguous United States/Canada/Alaska/Caribbean/Mexico/Central America (excludes Hawaii in US 48). Approximate Retail Value ("**ARV**") of the Grand Prize package: \$2,950. Two (2) prize winners will each receive two (2) pairs of tickets to a mutually agreed upon regular season Devils home game during the 2025-26 season. Approximate Retail Value ("**ARV**") of each prize: \$300.

7. **Prize and Travel Restrictions:**

As for the Prize:

Exact seating location and game shall be determined by DAE in its sole discretion. Winner's use of the prize shall be subject to additional ticketing terms and conditions found on <https://www.nhl.com/devils/team/devils-membership-terms-conditions> or such other website as made known to the winner by DAE (the "Ticket Terms and Conditions"). The Ticket Terms and Conditions shall be subject to change from time-to-time without prior notice to the winner. Notwithstanding anything contained herein or the Ticket Terms and Conditions to the contrary, the winner shall not receive any replacement, substitute, or alternative prize (including tickets) in the event the applicable New Jersey Devils home game is not held at the Prudential Center for any reason.

Winners and permitted guest of winner are responsible for obtaining travel arrangements at their own expense to and from all activities and events that are components of the prize and hereby acknowledge that Sponsor has not and will not obtain or provide travel insurance or any other form of insurance for any travel associated with the prize.

As for the Grand Prize:

Sponsor will provide round trip coach-class airfare for winner and his or her guest ("Companion") from an airport close to the winner's home to Nashville, Tennessee. Winner and Companion must travel together on the same itinerary. Sponsor or its designee will determine which airport is closest to the winner's home. Sponsor will provide ground transportation (1) to and from airport to winner's home and (2) to and from destination airport to lodging of winner and Companion at the prize trip destination. Sponsor will provide winner and Companion one double-occupancy lodging for two nights at a location in or around Nashville, TN. Air transportation, hotel accommodations, ground transportation, and other elements of prize are determined by Sponsor or its designee and must be taken together and cannot be taken separately. The Sponsor or its designee will not replace any lost or stolen tickets, travel vouchers or certificates or similar items once they are in the winner's possession. To be eligible to travel to Nashville, Tennessee, a Companion that is a Minor must be at least 13 years old and accompanied by his or her parent or legal guardian on the trip. Companion (and Companion's parent or legal guardian if a Minor) agrees to release and indemnify Sponsor pursuant to these Official Rules, and as otherwise set forth in a liability/publicity release.

As for both the Prize and Grand Prize:

Winners and permitted guest of winner must comply with all venue rules and regulations, including, without limitation, policies and procedures relating to COVID-19 (e.g., testing, social distancing, limited capacity, and face masks).
