OFFICIAL RULES. The following rules (the “Official Rules”) apply to the below-referenced Promotion.

PROMOTION PERIOD. The “2025 Grizzmas Sweepstakes” (the “Promotion”) begins December 2, 2025 at 12:00 AM CST and ends December 25, 2025 at 11:59 PM CST (the “Promotion Period”). **Multiple entry periods exist within the Promotion Period.** Each entry period starts and ends on the same day, beginning with “Day Two of Grizzmas” on December 2, 2025 and concluding with “Day Twenty-Five of Grizzmas” on December 25, 2025, starting at 12:00 AM CST and ending 11:59 PM CST (each an “Entry Period” and collectively the “Entry Periods”). The Promotion is offered only in the states of Tennessee, Mississippi, and Arkansas, subject to the eligibility requirements set forth below.

NO PURCHASE NECESSARY: A purchase will not improve your chances of winning. Void where prohibited by law. This promotion is not a gambling activity under Tennessee law as it offers a free method of entry and winners are selected randomly, not based on any payment or consideration.

ELIGIBILITY: The Promotion is open only to legal residents of Tennessee, or legal residents of Arkansas or Mississippi living within one-hundred fifty (150) miles of FedExForum, who are at least eighteen years of age at the time of entry. Promotion is void outside this area and where prohibited by law. Employees of Memphis Basketball, LLC or its affiliated companies and agencies, Sponsor, the National Basketball Association (“NBA”) and its Member Teams, NBA Properties Inc., employees, agents, and each of their respective their immediate families (parents, children, siblings, spouse) and household members are not eligible to participate in the promotion.

In addition, Entrants must have the Official Memphis Grizzlies Mobile App downloaded and must have signed up to receive Mobile Tickets prior to entering the Promotion.

TO ENTER. During each Entry Period, individuals (the “Entrants”) may enter the Promotion for an opportunity to win a prize (the “Prize”). Released Parties are not responsible for injury or damage to participants’ or to any other person’s computer or other device related to or resulting from participating in this Promotion or downloading materials from or use of the websites used in connection with the Promotion.
