As a legal requirement for participating in this Promotion as an Entrant ("Nominator" or "You") hereby agree to be bound by these Sweepstakes Rules (the "Rules") which form a legal contract by and between You and Sponsor. 1. CONTEST.

1.1. Contest Description. Entrant ("Nominator") agrees to prepare and submit the required nomination form to nominate a teacher ("Participant") for the Teacher of the Month ("Contest"). After submission, Participant may or may not be deemed a Winner (as defined in Section 5.1) subject to eligibility and compliance with these Rules. 2. SWEEPSTAKES.

2.1. Sweepstakes Description. Entrant ("Nominator") can also complete the required form for the sweepstakes in accordance with the Official Rules as described herein ("Sweepstakes"). After submission, Nominator may or may not be deemed a Winner (as defined in Section 5.1) subject to eligibility and compliance with these Rules. - 3.1.6. Promotion Start Date (October): 10/01/25 at 12:00 am PT. Promotion End Date (October): 10/31/25 at 11:59 pm PT.
- 3.1.7. Promotion Start Date (November): 11/01/25 at 12:00 am PT. Promotion End Date (November): 11/30/25 at 11:59 pm PT.
- 3.1.8. Promotion Start Date (December): 12/01/25 at 12:00 am PT. Promotion End Date (December): 12/31/25 at 11:59 pm PT.

(collectively, the "Promotion Period").

Rules. By participating in the Promotion, both Participant and Nominator unconditionally accept and agree to comply with and abide by these Rules, waive any right to claim ambiguity in the Rules or Sweepstakes related advertising/materials and agree that the decisions of Wit or Sponsor with respect to the Sweepstakes and any prize awards shall be final and binding in all respects. Sponsor reserves the right to alter the terms of these Official Rules at their discretion. 4. ELIGIBILITY.

Eligible Entrants. The Sweepstakes is open only to legal residents of the fifty (50) United States, the District of Columbia, U.S. overseas territories, except for New York, Florida, and Rhode Island, and possessions who are of eligible age to participate in their jurisdiction and 18 years of age or older, or, if in Alabama or Nebraska 19 years of age or older, and in Mississippi 21 years or older, and legal residents of Canada who do not reside in the province of Quebec, who have reached the age of majority in their province or territory. Minor Participants. 5. PRIZES.

<u>5.1. Prizes Awarded</u>. There will be one (1) Contest Winner during each Entry Period, eight (8) total Contest Winners. At the conclusion of each Promotion Period,, ten (10) Participants will be selected as finalists from all eligible nominations received to date, based on impact and thoughtfulness. From the ten (10) finalists, one Winner will be selected via a randomized drawing each month. All non-winning entries will roll over and remain eligible for finalist consideration in future months (through the end of the campaign). There will be twenty-one (21) Sweepstakes Winners during each Entry Period, 168 total Sweepstakes Winners. After completing the required nomination form, Nominators will have the chance to win an instant prize.

- 5.2. Chances of Winning. A mathematical algorithm is used to determine winners based on a probabilistic function that reduces the chances of winning at any given point in time as the number of available prizes goes down. Prizes are allocated equally among all geographic and population regions in which the Contest is offered.

Nominators must fully complete and submit all non-optional data requested on the online entry form to be eligible. Incomplete or inaccurate entries are void. All entries must include a valid email address for the Nominator.

- 7. No Automated Entries. All automated or robotic Entries submitted by individuals or organizations will be disqualified. All Entries by Entrants must be made manually by such Entrants.
