- Rules. By participating in the Sweepstakes, Entrant unconditionally accepts and agrees to comply with and abide by these Rules, waives any right to claim ambiguity in the Rules or Sweepstakes related advertising/materials and agrees that the decisions of Wit or Sponsor with respect to the Sweepstakes and any prize awards shall be final and binding in all respects. Sponsor reserves the right to alter the terms of these Official Rules at their discretion. 2. ELIGIBILITY.

- 2.1 <u>Eligible Entrants.</u> The Sweepstakes is open only to legal residents of the State of Michigan who are 18 years of age or older. By participating, Entrants agree to be bound by these Rules and the decisions of Wit or Sponsor, which are binding and final on matters relating to this Sweepstakes.
- Non-eligible Persons. There will be one (1) Grand Prize consisting of two (2) lower level seats to the Detroit Lions game on December 21, 2025, for one (1) winner and one (1) guest at Ford Field. Total Approximate Retail Value of the Grand Prize is \$820.00. All potential winners are subject to verification by Sponsor or Wit, whose decisions are final. All federal, state and local taxes and all other costs associated with prize acceptance and use not

- specified herein as being provided are the sole responsibility of the winner.

- 4.2 One (1) entry per entrant. Entrants must fully complete and submit all non-optional data requested on the online entry form to be eligible. Incomplete or inaccurate entries are void. All entries must include a valid email address for the Entrant.
- 5. No Automated Entries. All automated or robotic Entries submitted by individuals or organizations will be disqualified. All Entries by Entrants must be made manually by such Entrants. Any attempt by an Entrant to submit multiple Entries by using multiple/different email addresses, phone numbers, identities, registrations, logins or any other methods will void such Entrant's Entries and that Entrant may be disqualified. Wit's database clock will be the official timekeeper for this Sweepstakes.

Sponsor and Wit are not responsible for any delay or failure to receive notification for any reason, including inactive account(s), technical difficulties associated therewith, or an Entrant's failure to adequately monitor the Wit app or website. Any winner notification not responded to by the Entrant, within twenty-four (24) hours of the date notice or attempted notice is sent, or returned as undeliverable may result in prize forfeiture. The potential prize winner may be required to sign and return an affidavit of eligibility and release of liability, and a publicity release which must be received by Administrator, within twenty-four (24) hours of the date notice or attempted notice is sent, in order to claim any prize (collectively "Prize Claim Documents").
