## 2025 Southeast Michigan Ford Dealers Fan Tunnel Sweepstakes Rules

Welcome to the Southeast Michigan Ford Dealers Fan Tunnel Sweepstakes (the "Sweepstakes"), sponsored by DLI Properties, LLC ("Sponsor"). PLEASE READ THESE SWEEPSTAKES RULES CAREFULLY BEFORE ENTERING INTO THE SWEEPSTAKES.

As a legal requirement for participating in this Sweepstakes as an entrant ("Entrant" or "You") hereby agree to be bound by these Sweepstakes Rules (the "Rules") which form a legal contract by and between You and Sponsor. - Rules. By participating in the Sweepstakes, Entrant unconditionally accepts and agrees to comply with and abide by these Rules, waives any right to claim ambiguity in the Rules or Sweepstakes related advertising/materials and agrees that the decisions of Wit or Sponsor with respect to the Sweepstakes and any prize awards shall be final and binding in all respects. Sponsor reserves the right to alter the terms of these Official Rules at their discretion. Any such changes to the Official Rules will be prominently displayed and any conflicting changes to the Official Rules will be superseded by the most recent version of the Official Rules.
- 1.4 <u>Sweepstakes Administration</u>. Wit, on behalf of Sponsor, performs the collection, submission or processing of Entries, as well as the overall administration of the Sweepstakes. ## 2. ELIGIBILITY.

- **2.1** Eligible Entrants. The Sweepstakes is open only to legal residents of the State of Michigan who are of 18 years of age or older. By participating, Entrants agree to be bound by these Rules and the decisions of Wit or Sponsor, which are binding and final on matters relating to this Sweepstakes.
- Non-eligible Persons. Sponsor, its parents, subsidiaries, affiliates, distributors, retailers, sales representatives, Sweepstakes administrator, advertising and promotion agencies; and each of their respective officers, directors, employees, consultants and contractors (the "Sponsor Entities"), are ineligible to enter the Sweepstakes or win any related prize. <u>Prizes Awarded</u>. There will be one hundred (100) total winners. Ten (10) winners will be selected from each Entry Period. The winners will be randomly selected from eligible Entries on or about the above approximate drawing date for the Entry Period the Entrant entered for, after the conclusion of that Entry Period. Odds of winning depend on the number of eligible entries received. Ten (10) winners from each Entry Period will be randomly selected and awarded two (2) single game tickets to one (1) Detroit Lions home game for the 2025 season, one (1) parking pass, and two (2) spots in the pregame fan tunnel experience ("Prize"). Approximate Retail Value of each Prize is \$500. All potential winners are subject to verification by Sponsor or Wit, whose decisions are final. All federal, state and local taxes and all other costs associated with prize acceptance and use not

- specified herein as being provided are the sole responsibility of the winner.
- 3.2 Prizes cannot be transferred, redeemed for cash or substituted by an Entrant. Sponsor reserves the right in its sole and absolute discretion to award a substitute prize of equal or greater estimated value if a prize described in these Rules is unavailable or cannot be awarded, in whole or in part, for any reason. The estimated value of the prize represents Sponsor's good faith determination. That determination is final and binding, and cannot be appealed. If the actual value of the prize turns out to be less than the estimated value, the difference will not be awarded in cash. Sponsor makes no representation or warranty concerning the appearance, safety or performance of any prize awarded. Sponsor will not replace any lost or stolen prize items.
- 4. HOW TO ENTER. Entrants may enter the Sweepstakes during the Sweepstakes Period online by visiting the Wit website and doing the following:

  - Southeast Michigan Ford Dealers. During the Sweepstakes Period, an entrant may receive a link to the Sweepstakes Landing Page by scanning the QR Code on select promotion materials at participating Southeast Michigan Ford Dealer locations. An entrant may center the QR Code in the camera of their mobile device to scan the QR Code. Once completed, entrant will receive a link to the Sweepstakes Landing Page and follow the steps above to enter. An entrant cannot participate solely by scanning the QR Code.
- 4.2 One (1) entry per Entrant. Entrants must fully complete and submit all non-optional data requested on the online entry form to be eligible. Incomplete or inaccurate entries are void. All entries must include a valid email address for the Entrant.
- 5. No Automated Entries. All automated or robotic Entries submitted by individuals or organizations will be disqualified. All Entries by Entrants must be made manually by such Entrants. Any attempt by an Entrant to submit multiple Entries by using multiple/different email addresses, phone numbers, identities, registrations, logins or any other methods will void such Entrant's Entries and that Entrant may be disqualified. Final eligibility for the award of any prize is subject to the eligibility verification of these Rules. All Entries must be submitted by the end of the Sweepstakes Period in order to participate. Wit's database clock will be the official timekeeper for this Sweepstakes.
- Winner Selection. The Sweepstakes winner(s) will be notified by e-mail at the end of each entry period. Sponsor and Wit are not responsible for any delay or failure to receive notification for any reason, including inactive account(s), technical difficulties associated therewith, or an Entrant's failure to adequately monitor the Wit app or website. Any winner notification not responded to by the Entrant, within twenty-four (24) hours of the date notice or attempted notice is sent, or returned as undeliverable may result in prize forfeiture. The potential prize winner may be required to sign and return an affidavit of eligibility and release of liability, and a publicity release which must be received by Administrator, within twenty-four (24) hours of the date notice or attempted notice is sent, in order to claim any prize (collectively "Prize Claim Documents"). potential winner forfeits the prize.
