# THE MILITARY APPRECIATION NIGHT TICKET SWEEPSTAKES OFFICIAL RULES

# NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED

The MILITARY APPRECIATION NIGHT TICKET SWEEPSTAKES ("Sweepstakes") begins on June 20, 2025 at 12:00 a.m. Eastern Time (ET) and ends on July 1, at [11:59 p.m.] ET (the "Sweepstakes Period"). By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and be bound by these Official Rules and the decisions of Verizon Corporate Services Group Inc. and Orlando Sports Holdings, LLC ("Orlando City SC") (collectively "Sponsors"), and Wit Labs, Inc ("Wit") ("Administrator"), which are binding and final in all respects.

# 1. ELIGIBILITY

The Sweepstakes is open to individuals who: (i) are at least 21 years of age or the age of majority in their state of residence at the time of entry in the Sweepstakes; (ii) are legal residents of Florida; and (iii) are NOT in one or more of the "Prohibited Persons" categories listed below. Any entry submitted by any ineligible person(s) will be void.

Prohibited Persons. "Immediate family" members include spouses, grandparents, parents, children and grandchildren, whether by marriage, past marriages, remarriage, adoption, cohabitation or other family extension.

# 2. HOW TO ENTER

During the Sweepstakes Period there are two ways to enter:

- I. QR code method: Visit a participating Verizon retail location and, using an internet-enabled mobile device, scan the QR code to connect to the Sweepstakes entry microsite and accurately complete and submit the entry form, including your full name, email address, phone number. Once you have completed the foregoing, you must agree to the Official Rules and Privacy Policy and click the "submit" button; (each an "Entry"). Entries must be received by the participating stores close of business on July 1, 2025. Data usage rates may apply to access the Sweepstakes microsite.
- II. Mail-in Method. During the Sweepstakes Entry Period, Entrants will be able to submit their entry by sending their name, address and phone number on a 3' X 5' piece of paper to Military Appreciation Night Sweepstakes, Attn: Legal Department, 655 W. Church Street, Orlando, Florida 32805 (a "Postcard Entry"). Postcard Entry must be postmarked no later than July 1, 2025. By submitting your entry information to the address provided, you will receive one (1) entry in the Sweepstakes.

#### 3. CONDITIONS APPLICABLE TO ALL ENTRIES

Limit one (1) entry per person and per email address during the Sweepstakes Period. Orlando City SC's computer is the official time-keeping device for the Sweepstakes. All received entries become the exclusive property of Sponsors and will not be acknowledged or returned, and no correspondence will be entered into. Any attempt by an entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and/or logins, or any other methods will void that entrant's entries and that entrant may be disqualified. The use of automated entry devices or any other

conduct that impedes the integrity of the Sweepstakes is prohibited. Any individual who attempts to enter using false contact information or who uses any unauthorized device or artifice to enter using a false identity. as determined by Sponsor, will be disqualified. If there is a dispute as to who submitted an entry, the entry will be deemed submitted by the Authorized Account Holder of the email address submitted at the time of entry, "Authorized Account Holder" is defined as the natural person assigned to an email address by an internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the email address in question. <u>Prize</u> Each winner will receive four (4) single-game tickets located in the West Club section of Inter&Co Stadium to the Orlando City SC Military Appreciation Night presented by Verizon on July 12, 2025 (the "Prize"). A total of five (5) prizes are available to be awarded (each "prize" and collectively "Prizes". **Approximate Retail Value of the Prize is \$300 (\$75 per ticket)**. **Total Retail Value of all Prizes is \$1,500**

Sponsors will attempt to notify potential winners via email and/or phone, using information provided on the Entry form. Potential winners will be required to follow prize claim instructions provided and return all necessary prize claim documents within three (3) business days from the date of notification. Potential winners must complete and sign a Prize Acceptance & Liability Waiver and a Publicity Release before the Prize will be awarded. The Prize will be forfeited in the event that: (i) the potential winner is not in compliance with these Official Rules, including any eligibility requirements; (ii) the prize notification or attempted notification is returned as undeliverable; (iii) Sponsors do not receive timely response to prize notification; or (iv) a potential winner declines the Prize offered.
