ELIGIBILITY: The Nashville Hockey Club LP d/b/a the Nashville Predators (“Administrator”) is conducting the 2025 Unlock the Vault Sweepstakes (the “Sweepstakes”), presented by Regions Bank (“Sponsor”), which is open to permanent, legal residents of the States of Tennessee, Georgia, Alabama, Mississippi, and Kentucky (the “Territory”) who are at least eighteen (18) years old at the time of entry (the “Participant(s)”). The First Monthly Entry Period shall run from October 4, 2025 at 11:00 AM CT through October 31, 2025 at 11:59 PM CT, the Second Monthly Entry Period shall run from November 1, 2025 at 12:00 AM CT through November 30, 2025 at 11:59 PM CT, the Third Monthly Entry Period shall run from December 1, 2025 at 12:00 AM CT through December 31, 2025 at 11:59 PM CT, the Fourth Monthly Entry Period shall run from January 1, 2026 at 12:00 AM CT through January 31, 2026 at 11:59 PM CT, the Fifth Monthly Entry Period shall run from February 1, 2026 at 12:00 AM CT through February 28, 2026 at 11:59 PM CT, the Sixth Monthly Entry Period shall run from March 1, 2026 at 12:00 PM CT through March 31, 2026 at 11:59 PM CT, and the Seventh Monthly Entry Period shall run from April 1, 2026 at 12:00 PM CT through April 16, 2026 at 11:59 PM CT. Entry must be submitted within the time frame specified to be considered for a Prize. During the Entry Period, Participant must complete the entry form available at [2025 Unlock the Vault Sweepstakes](#) by providing the necessary information to submit a complete entry form (the “Entry”). All Monthly Entries received during the Entry Period will be automatically entered into the Grand Prize drawing. Online Entries must be manually key-stroked and no Participant can submit more than one (1) Entry per Monthly Entry Period. No Entries will be accepted by mail or by delivery to the offices of the Administrator.
