

**Portland Timbers Create Your Own Zenner's Recipe Sweepstakes
Official Rules**

Open only to entrants who are eighteen (18) years of age and are legal residents who live within a 75-mile radius of Providence Park, located at 1844 SW Morrison Street, Portland, Oregon 97205 (the "Territory") at the time of entry ("Entrants"). Entries will only be accepted through

The Sweepstakes begins at 12:00 a.m. Pacific Time on June 4, 2025, and ends at 11:59 p.m. Pacific Time on June 24, 2025.

1. **Eligibility.** The Portland Timbers Sweepstakes (the "Sweepstakes") is open to legal residents of Oregon and Washington within the Territory who are 18 years of age or older at the time of entry. Persons in the following categories are NOT eligible to participate or win a prize in the Sweepstakes: (a) Sponsor, Peregrine Sports LLC ("Sponsor's Affiliate"), Zenner's Quality Meat Products, Inc. 3. **How to Enter.** No purchase necessary to enter or win. No other method of entry will be accepted. All requested information must be provided for an Entry to be valid. Each Entrant may only submit one (1) Entry; Sponsor reserves the right, in its sole discretion, to void any and all Entries of an Entrant who submits more than one (1) Entry. Entries become the property of Sponsor and will not be returned. Entries and Entrants may be subject to verification by Sponsor in its sole discretion. Any attempt by any Entrant to obtain more than the stated number of Entries by using multiple/different addresses, identities or registrations, or any other methods will void that Entrant's Entries and that Entrant may be disqualified. Use of any automated, robotic, repetitive, programmed or similar entry methods or agents to enter is prohibited and will result in disqualification. Incomplete Entries or Entries not complying with these Official Rules are subject to disqualification, at Sponsor's sole discretion. Proof of submission does not constitute proof of Entry. 5. **Selection.** Sponsor will award eleven (11) Prizes (defined below) to randomly selected Entrants from all qualified Entries (each, a “Winner” and together, the “Winners”). Sponsor will select the Winners in its sole discretion. The authorized representative submitting the Entry on behalf of each Winner will be notified by e-mail and/or telephone (in the sole discretion of Sponsor) on or about July 1, 2025. To claim the Prize, the Winner must follow the instructions contained in the Prize notice and, if required by Sponsor, must sign and return an Affidavit of Eligibility and Release and unless prohibited by law, a Release of Publicity, as further described in Section 8 below. In the event that an eligible Winner does not claim the Prize within three (3) calendar days after delivery of notification, then in Sponsor’s discretion and time permitting, the Prize may be awarded to another randomly selected Winner. Odds of being selected a Winner of the Prize depends on the number of eligible Entries received by Sponsor. In the event of a dispute as to the identity or eligibility of a potential Winner based on an e-mail address, the applicable Entry will be declared made by the Authorized Account Holder of the e-mail address submitted at the time of Entry. As used herein, the “Authorized Account Holder” is defined as the natural person to whom the applicable Internet service provider or other organization (such as a business or educational institution) has assigned the e-mail address for the domain associated with the submitted e-mail address. Sponsor’s decisions will be final and binding on all matters relating to the Sweepstakes selections.

In addition, Sponsor will review eligible Entries received during the Sweepstakes Period with Zenner’s and its concessionaire, judging each recipe based on the following criteria: taste, visual appeal, ease of preparation, creativity, and crowd appeal. Sponsor reserves the right to make modifications to any such recipe, including, in its sole discretion, by substituting any ingredients included in such recipe. Sponsor will select up to four (4) Entries to compete in a contest against additional recipes created by Sponsor’s concessionaire. Sponsor’s decisions will be final and binding. Entrants will not be notified if their recipe is selected. Sponsor will ask its fans to vote on their favorite recipes of the available options. The recipe voted as the winner will be featured at the Portland Timbers match on July 5, 2025 and may be featured at future events at Providence Park in Sponsor’s sole discretion. No prize will be awarded to the Entrant who submitted the winning Entry and the Entrant will not be notified. Entrants further agree and acknowledge that no royalties, monies, or consideration of any kind will be payable in connection with any recipe submitted as part of an Entry.

6. **Prize and Approximate Retail Value (“ARV”).**

- **Prizes for Winning Entries (each, a “Prize”):** Each Winner will receive the following:
 - \$25 vouchers for any concession stand at Providence Park – ARV: \$25.00
- **Grand Prize for Winning Entry (each, a “Grand Prize”):** One Winner will receive the following:
 - Zenner's provided hot dogs, sausages, condiments, grilling gear, merch – ARV: \$300.00
- **Total ARV of all Prizes: \$250.00**

The Prize is non-refundable for cash and expires on December 31, 2025. Additional terms and conditions may apply to Winner’s Prize.

7. **Prize Restrictions: Limit one (1) Prize per person.** All costs and expenses associated with Prize acceptance and use not specified herein as being provided, including but not limited to lodging accommodations, any transportation costs, luggage fees, meals, gratuities and other expenses incurred

by accepting the Prize, are the sole responsibility of the Winner. Sponsor does not make, nor in any manner is responsible or liable for, any warranty, representation or guarantee, express or implied, in fact or in law, relative to the Prize including but not limited to its quality, fitness for purpose, or condition. Prize is non-transferable and non-assignable, with no cash redemptions or substitutions except at Sponsor's sole and absolute discretion. Prize will be deemed void if sold, transferred, auctioned or assigned to any third party. Sponsor reserves the right in its sole discretion to substitute a Prize in whole or in part with one of comparable or greater value. 8. **Winner Notification/Prize Claims.** If a Prize is undeliverable to Winner or otherwise not claimed by Winner within three (3) calendar days after delivery of notification, or a potential winner is found to be ineligible or not in compliance with these Official Rules, the Prize will be forfeited by such Winner and, in Sponsor's sole discretion and time permitting, the Prize may be awarded to another randomly selected Winner. Winners are subject to verification. For the avoidance of doubt, Wit administers and provides the platform for the Sweepstakes but is not the sponsor of the Sweepstakes.
