- There will be a \$10.00 pet registration fee payable to WTC, Inc.
- Register Pet(s) at the WTC Community Office. Dog(s) and Cat(s) must display tag(s) issued by the Community Office while on WTC property.
- To keep the pet(s) indoors always unless under the immediate physical control of the Pet Owner.
- Not to allow the pet(s) in the Club facilities, swimming pool area, all tennis courts, all walkways around the tennis courts, Community Office, stadium, multi-purpose room and meeting room above the pro shop.
- Not to keep the pet(s) tied unattended in any WTC common area.
- To be responsible for the clean-up and disposal of pet droppings.
- Not to dispose of cat litter or waste in toilets.
- Not to leave the pet(s) unattended for any undue length of time.

WTC, Inc. Pet Registration; cont.:

- To be liable for any and all damage caused by the pet(s) to any part of the Condominium Unit, Condominium or HOA sub-associations.
- Not to keep the pet(s) for commercial purposes.
- Not to bring onto or keep in the Condominium Unit or HOA Residence at any time potbellied pigs, venomous snakes, Akita, Basenji, Chow, Doberman Pinscher, English Mastiff, Jack Russell Terriers, German Pinscher, German Shepherd, Malamute, Pit Bull, Presa Canario's or Rottweilers (including mixes thereof); or any other animals determined by the WTC Master Board of Directors sole and absolute discretion to be dangerous or a nuisance. The owner of such pet(s) may be required by the WTC Master Board of Directors to have the pet(s) DNA tested at the owner's expense to determine breed and type of the animal.
- To provide the pet(s) with adequate and regular veterinary care, including flea prevention, and ample food and water.
- Must comply with any and all Collier County laws and regulations regarding the housing and care of pet(s).

World Tennis Club, Inc. reserves the right, at any time, to prohibit any specific pet, which has not been permitted. In the event WTC, Inc. revokes permission to keep a pet, Pet Owner agrees to abide by said decision and permanently remove said pet from the Condominium Unit and/or HOA Residence as soon as reasonably possible; but in no event longer than 7 days after written notice of said decision.

VIOLATION OF ADDENDUM: Upon the first violation of this registration, a written warning will be issued to Pet Owner specifying the complaint. An owner may be subject to a \$300 fine upon second violation of this registration. Once a third violation is reached the Pet Owner will no longer be allowed a pet in the
