

Healing Hands Nominate your Vet Giveaway Official Rules

1. Introduction: Equine Network Foundation, (d/b/a *A Home For Every Horse (AHFEH)*) (“Sponsor”) is offering the Healing Hands Nominate Your Vet Giveaway (“Contest”). NO PURCHASE NECESSARY. A PURCHASE DOES NOT IMPROVE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. Veterinarians who treat animals at any approved A Home for Every Horse partner rescue will be eligible.

2. Eligibility: Entrant must be eighteen (18) years of age or older as of August 1, 2025 (or age of majority in state of residence) and a resident of the fifty (50) United States and the District of Columbia. Employees of Sponsor or Prize Provider, immediate family (defined as parents, spouse, children, siblings, grandparents) of each such employees, subsidiaries, affiliated companies, agents and all those with whom such employees are domiciled are NOT eligible.

3. Timing: Contest begins at 12:00:01 a.m. E.S.T. on August 14, 2025 and ends at 11:59:59 p.m. E.S.T. on September 14, 2025. One winner will be selected and contacted on or around September 20, 2025 via phone or email.

Limit one [1] entry via an official entry form per participant. All required information/fields must be fully, accurately and legibly completed or entry may be voided. Contestants may enter once (1 time per person) during the Contest period. More than one (1) entry from any person or email address during the Contest period will void all entries from that person or email address. Sponsor is not responsible for late or incomplete entries. If a problem occurs in the online submission process, Entrant should receive an “Error” message. However, the responsibility to electronically complete the Entry process is the Entrant’s and neither the Sponsor nor the Contest Administrator shall be responsible for any entry not actually received due to incomplete or improper transmission.
