

## Fly-Free Year Sweepstakes: Spalding's Ultimate Fly Control Package Official Rules

Limit one [1] entry via an official entry form per participant. All required information/fields must be fully, accurately, and legibly completed or entry may be voided. Contestants may enter once (1 time per person) during the Contest period. More than one (1) entry from any person or email address during the Contest period will void all entries from that person or email address.
