

Trot and Track Sweepstakes Official Rules

1. Introduction: Equine Network, LLC (d/b/a The Horse ("Sponsor")) is offering the Trot and Track Sweepstakes ("Contest"). NO PURCHASE NECESSARY. A PURCHASE DOES NOT IMPROVE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

Eligibility: Entrant must be eighteen (18) years of age or older as of August 1, 2026 (or age of majority in state of residence) and a resident of the fifty (50) United States and the District of Columbia. Contestants may enter once (1 time per person) during the Contest period.
