## Website Terms of Use

Last Modified and effective as of April 15, 2018

### Acceptance of the Terms of Use

These terms of use are entered into by and between You and Deserve, Inc. (formerly known as Tremus Inc. or SelfScore, and referred herein as “Company”, “we” or “us”).
