A 50% deposit is due at the time of booking (within 24 hours) to secure the booth and final payments for booth space is due by December 29, 2023. Cancellations before December 29, 2023, will receive a full refund. You can pay the deposit via Credit Card, ACH or Wire transfer within the Exhibitor Registration Portal

**Small developing Businesses/Consultants qualified to the following WMS set standards:

\$5M or less in annual revenue by the company's FY (each year, not average as is the case with SBA)

1. 25 employees or less (each year, not average)
2. In business 5 years or less
3. Not affiliated with a Medium or Large Business, Alaska Native Corporation (ANC), or other large association.

Qualified Developing SBs in this category can return to the WMS tabletop pavilion for as many years as desired until they exceed any one of the 4 above qualifying standards, whichever comes first.)
