DESCRIPTION

These centrifugal pumps are engine-driven, self-priming (to 20 ft. lift), portable units, shipped completely assembled and mounted. Pumps include a clog resistant impeller capable of handling solids as large as 3/8" diameter (up to 25% by volume). A built-in check valve assists in priming and a mechanical shaft seal prevents leakage. Suction and discharge ports are 2" NPT female pipe thread. Handle liquids from 40° to 180° F (4° to 82° C). For use with nonflammable liquids compatible with pump component materials.

MAINTENANCE

AWARNING

To prevent accidental starting always remove the spark plug, or disconnect and ground the spark plug wire before attempting to service or remove any component.

CLEANING

This unit has been designed with a removable volute enabling the pump to be cleaned or unclogged with ease. Remove casing and volute as described in steps 1 and 2 under MECHANICAL SEAL REPLACEMENT. Remove any debris found inside the unit, reassemble as described in steps 16 and 17 under MECHANICAL SEAL REPLACEMENT.

NOTE: Depending on application, it may be necessary to remove suction and discharge hoses.

MECHANICAL SEAL REPLACEMENT




Figure 1 - Mechanical Seal Replacement




Figure 2 - Repair Parts Illustrations

Refer to Figures 1 and 2

IMPORTANT: Always replace the seal seat (Ref. No. 5), seal head (Ref. No. 6) and shaft sleeve (Ref. No. 7) to ensure proper mating of mechanical seal components.

- 1. Unthread cap screws (Ref. No. 14) and remove casing (Ref. No. 12) and o-ring (Ref. No. 4) from the adapter (Ref. No. 3).
- Unthread round head screws (Ref. No. 15) and remove volute (Ref. No. 10) from adapter.
- Unscrew impeller (Ref. No. 9) from the engine shaft. Remove the impeller shim(s) (Ref. No. 8), shaft sleeve and seal head from engine shaft.

NOTE: To keep the shaft from turning, remove the shroud from the engine and hold the flywheel in place.

- Unthread hex flange screw (Ref. No. 2) and remove the adapter from the engine mounting face.
- 5. Push seal seat from the adapter recess with a screwdriver.
- 6. Clean the adapter recess before inserting a new seal seat.
- 7. Carefully wipe the ceramic surface of the new seal seat with a clean cloth.
- Wet the outside of the rubber portion of the seal seat with a light coating of soapy water.
- Press the new seal seat squarely into the cavity in the adapter. Use finger pressure only to avoid scratching the seal seat (This is a lapped surface and must be handled very carefully).
- After the seal seat is in place, be sure that it is clean and has not been marred.

- 11. Using a clean cloth, wipe the shaft and make certain that it is perfectly
- 12. Secure the adapter on the engine mounting face.

A CAUTION

Tighten hex flange screws EVENLY to avoid cocking rabbet on engine mounting face.

13. Apply a light coating of soapy water to the inside rubber portion of seal head and slide onto the shaft sleeve. Slip the shaft sleeve with seal head onto the engine shaft with the black carbon face toward the white ceramic seal seat.

A CAUTION

Do not touch or wipe the face of the polished surface part of the seal head.

- 14. Replace any impeller shim(s) removed in disassembly.
- 15. Screw impeller back in place, tightening until it is against the shaft sleeve.
- 16. Remount volute and position o-ring in place.

IMPORTANT: Always inspect o-ring. Replace when cracked or worn. Wet o-ring with soapy water for ease of assembly.

17. Remount casing.

SHIM ADJUSTMENT

 When installing a replacement engine, adapter, impeller, shaft sleeve, volute or casing, it may be necessary to vary the number of impeller shims (Ref. No. 8) that will be required. This is easily done by adding one shim more than was removed and reassembling the pump as described in MECHANICAL SEAL REPLACEMENT section.

NOTE: When adding or removing shims, it is best to proceed with a 0.010" increment each time. Remove spark plug wire from engine and ground. While tightening the unit together, turn the shaft (by pulling on the recoil starter etc.); feel for the shaft seizing. If shaft begins to seize before the fasteners are completely tight, disassemble the pump and remove one shim and repeat assembly.

- Once having added one shim more than original, be sure that the volute (Ref. No. 10) and adapter (Ref. No. 3) are firmly fitted (check fasteners, Ref. Nos. 2 & 15). When engine turns freely, add shims until it does strike, then remove a 0.010" shim. This should allow the proper clearance.
- Proper running clearance for the impeller should be as close as possible to volute without striking; maximum clearance is 1/32" (0.032").
- Follow the above procedure until proper clearance is obtained. This will ensure maximum performance.

PRICES: Prices are subject to change without notice. All orders accepted are subject to prices in effect at time of shipment.

PAYMENT TERMS: Terms, upon establishment of credit, are Net 30 days. Past due accounts may be subject to a service charge of 1.5% per month. Domestic or assignable letter of credit is required for all export trade.

The expedited shipping charges are an additional cost added separately from the VIP charges per item. AMT reserves the right to revise lead times as required due to availability of materials and all other causes beyond our control. QSP quantities are limited as determined by AMT.

ALL purchase orders must be submitted via hard copy sent to AMT customer service department by fax, EDI or e-mail.

RETURN GOODS POLICY: Goods shall not be returned without a return goods authorization number (RGA) issued by AMT customer service. The RGA number must be listed on the packing list. 

3-Inch Solids-Handling Pumps



Refer to pump manual 1808-633-00 for General Operating and Safety Instructions.

DESCRIPTION

These centrifugal pumps are high capacity, engine driven, self-priming (to 20 ft. lift), portable units, shipped completely assembled. Equipped with precision lapped mechanical seal to reduce the likelihood of leakage, and a clog resistant cast iron impeller and wear plate capable of handling solids up to 3/4" in diameter. Suction and discharge ports are 3" NPT pipe thread. Pumps are designed for operation involving irrigation and dewatering of excavations, basements, etc. Handle liquids from 40° to 180° (4° to 82° C). For use with nonflammable, non-abrasive liquids compatible with pump component materials. Pumps are constructed of cast iron with either Buna-N or Viton mechanical seal components (see specifications). Viton is recommended for pumping alachlor herbicides (e.g. Monsanto Lasso®) or other compatible liquids.

MAINTENANCE

AWARNING

Always disconnect battery cables and spark plug wire from spark plug before performing any maintenance operation requiring disassembly of the pump.

MECHANICAL SEAL REPLACMENT




Figure 1 - Mechanical Seal




Figure 2 – Repair Parts Illustration

Refer to figures 1 and 2.

NOTE: Always replace seal assembly (Ref. No. 7) and shaft sleeve (Ref. No. 8) to ensure proper mating of mechanical seal components (models 327A and 327B have no shaft sleeve).

- Remove pump casing (Ref. No. 3), gasket (Ref. No. 9) and impeller (Ref. No. 5).
- 2. Remove the shaft sleeve with the seal head on it.
- 3. Remove seal head from rear of impeller.
- Remove the adapter (Ref. No. 10) and push seal seat from adapter recess with a screwdriver.
- 5. Thoroughly clean all surfaces of the adapter recess.
- Using a clean cloth, wipe the polished surface of the seal head.
- Wet the rubber portion of the new seal with a light coating of soapy water. Press seal seat squarely into adapter recess.
 Avoid scratching the white ceramic surface.

NOTE: Handle all seal parts with extreme care and attention to keeping them clean. Do not touch seal faces (either ceramic or carbon) with your hands. Do not put lubricants of any kind on seal faces. This can cause the seal to leak.

- 8. Inspect the ceramic face of the seal seat and carbon face of the seal head to ensure they are clean and not marred.
- Wet the inside rubber portion of the new seal head with a light coating of soapy water. Slide head onto shaft sleeve. Slip the shaft sleeve with seal head onto the engine shaft.

IMPORTANT: Before installing new shaft sleeve, apply a bead of non-hardening, pliable sealant (such as Permatex® Form-A-Gasket® No. 2) to motor shaft shoulder.

 Wet the inside rubber portion of the new seal head with a light coating of soapy water. Slide head onto the rear of impeller.

NOTE: Reinstall any shims or spacers that may have been removed onto engine shaft or into impeller before installing impeller.

- Screw impeller back in place, tightening until it is against the end of the engine shaft.
- Replace adapter gasket and casing and fasten with eight cap screws.
- 13. After assembly, turn engine shaft by hand slowly using recoil

- starter to check for striking of the impeller on the casing. If striking or rubbing occurs, adjust impeller shims (see Shim Adjustment) as required and reconnect spark plug wire and battery cables.
- 14. A short "run-in" period may be necessary to provide completely leak-free seal operation.

IMPELLER REPLACEMENT

Impeller (Ref. No. 5) is subject to wear only by abrasive action of sandy or dirty fluid. If badly worn, all these parts can be replaced easily and the pump thus restored to full efficiency.

NOTE: When the clearance between the impeller exceeds 1/16" at the face of the impeller or 1/8" on the outside diameter of the impeller, it may be necessary to take corrective action. The increased clearance can cause lengthened priming times and reduced pumping capacity. If both the priming and capacity of your unit are satisfactory for your application, it is recommended that no corrective maintenance be performed regardless of what clearances on your unit may have developed, since the increased clearances in themselves are not generally harmful to your pump.

Normally, new pump clearances can be restored by simply shimming behind the impeller (add shim washers, Ref. No. 6). If the diameter of the impeller is badly worn or if 1/16" shim washers do not restore clearances to less than the 1/16" face dimension and/or the 1/8" diametral clearance, it is recommended that the impeller be replaced.

3-Inch Solids-Handling Pumps

SHIM ADJUSTMENT

When installing a replacement impeller or mechanical seal, it may be necessary to vary the number of shims (Ref. No. 6) that will be required. This is easily done by adding one 0.010" shim more than was removed and reassembling the pump as described. Ensure that the casing is snugly in place and check the shaft to make sure it is turning freely. If it turns freely, check to ensure that the adapter (Ref. No. 10) and the casing (Ref. No. 3) are tighten the fastener (Ref. No. 16) and tighten carefully, turning shaft while tightening. If shaft seizes before fasteners are completely tight, disassembly pump and remove one shim and repeat reassembly. If any time during the above operation the shaft does not turn free, or a metal-to-metal strike can be heard or felt when turning the shaft, follow the procedure indicated above and repeat the procedure. The above procedure ensures that the pump will have the proper running clearance (less than 0.010") between the impeller and casing and perform like a new unit.

FLAPPER VALVE/DISCHARGE PORT GASKET REPLACEMENT

Remove bolts connecting plate to casing. Remove flapper valve or gasket. Inspect surface of both casing and plate to be free with debris or dirt/rust. Clean off if necessary. Install new flapper value or gasket with original bolts.

SALES POLICY: AMT products are sold through our established Distributors. We do not sell direct to the consumer or organization not entitled to trade recognition. Therefore, possession of our catalogs and/or price list(s) does not infer an offer to sell.

MINIMUM ORDER: We appreciate your order, however, all orders are subject to a minimum \$35.00 net invoice charge (excluding freight). This applies to all pump and parts purchase orders.

PRICES: Prices are subject to change without notice. All orders accepted are subject to prices in effect at time of shipment.

PAYMENT TERMS: Terms, upon establishment of credit, are Net 30 days. Past due accounts may be subject to a service charge of 1.5% per month. Domestic or assignable letter of credit is required for all export trade.

PAST DUE ACCOUNTS: AMT reserves the right to withhold open account shipments on any past due account. Invoices are considered past due after thirty (30) days. In the interest of sound business, all orders are subject to approval of the Credit Department.

SHIPPING INSTRUCTIONS: All shipments will be made F.O.B. the factory. Where instructions for shipment do not appear on the order, the shipment will be made according to our best judgment. Full risk of loss (including transportation delays and losses) shall pass to the customer upon delivery of the products to the carrier at the F.O.B. point. When loss or delay occurs, primary responsibility for tracing rests with the customer. When there is LOSS or APPARENT VISIBLE DAMAGE to a shipment, when tendered for delivery, DO NOT give the carrier a clear receipt. Note such damage on the carrier's delivery receipt and HAVE THE DRIVER SIGN THE RECEIPT.

PRODUCT REVISIONS: AMT reserves the right to discontinue, change or improve its products or any portions thereof without being obligated to provide such a change or improvement for units sold and/or shipped prior to such a change or improvement.

LEAD TIME: Products designated "Quick Ship Product", also referred to as "QSP" will normally be shipped within 24 hours of receipt of a non-cancellable purchase order. Only limited quantities of "QSP" pumps are available.

STANDARD LEAD TIME: Lead time is two weeks for all non "QSP" product. AMT reserves the right to revise lead times as required due to availability of materials and all other causes beyond our control.

VIP SHIPMENT: Select AMT and IPT branded pumps are available for next day shipment for non-QSP (Quick Ship Products) items and subjected to a specific model surcharge per unit noted in the respective price book. Requires calling for availability, confirmation and a non-cancellable purchase order or credit card payment prior to shipment. The expedited shipping charges are an additional cost added separately from the VIP charges per item. AMT reserves the right to revise lead times as required due to availability of materials and all other causes beyond our control. QSP quantities are limited as determined by AMT.

ALL purchase orders must be submitted via hard copy sent to AMT customer service department by fax, EDI or e-mail.

RETURN GOODS POLICY: Goods shall not be returned without a return goods authorization number (RGA) issued by AMT customer service. The RGA number must be listed on the packing list. Only current model and part numbers with a valid date code may be returned (within one year from date of purchase). A 20% restocking and packaging charge will apply to all returns. All shipping charges must be pre-paid. No exceptions.

ORDER CHANGES BY CUSTOMER: Orders in process may not be changed except with written consent and may be subject to special charges.

12 Month Limited Warranty

EXTENT AND DURATION OF LIMITED WARRANTY

Coverage: AMT Pump Company (herein "AMT") or IPT Pumps by Gorman-Rupp (herein "IPT") or Gorman-Rupp Industries Division of the The Gorman-Rupp Company, Patterson, or the Gorman-Rupp Company (herein referred to as "G-R Unit) each individually warrants that its products and parts shall be free from defects in material and workmanship for twelve (12) months from the date of purchase by the original end user when installation is made and maintenance is performed in accordance with G-R Unit's recommendations. Wear and tear resulting from use and items normally consumed in use are not covered.

EXCEPTIONS

(A) This Limited Warranty shall not apply to mechanical seals in AMT or IPT pumps and the following products and parts: engines, motors, trade accessories and all other products, components, parts and materials not manufactured by the G-R Units. These items may, however, be covered by the warranties of their respective manufacturers. (B) This warranty does not extend to or apply to any unit which has been repaired or altered at any place other than by a G-R Unit, or by persons not expressly approved by a G-R Unit to make repairs or alterations, nor to any unit the serial number, model number or identification of which has been removed, defaced or altered. (C) This warranty does not extend to any product manufactured by a G-R Unit, which has been subjected to mis-use, neglect, accident, improper installation, or use in violation of instructions furnished by a G-R Unit. (D) Pump Kits: This warranty does not extend to any product sold by a G-R Unit unassembled as a Pump Kit. Pump Kits are warranted against defects in material and workmanship for 60 days from the date of shipment from a G-R Unit. Any Pump Kit parts deemed defective by a G-R Unit will be replaced free of charge within 60 days of shipment. Pump Kits are not returnable for credit.

LIMITATIONS

EXCLUSIVE REMEDY AND DAMAGES

The sole and exclusive remedy for breach of this Warranty by a G-R Unit and the entire extent of its liability for such breach or for damages arising from the use of the products and parts covered under this Limited Warranty, shall be as follows:

- Repair or Replacement: If inspection shows that any G-R Unit product or part covered under this Limited Warranty is defective in materials or workmanship, the G-R Unit shall repair or replace the defective or nonconforming product or part without charge, whichever the G-R Unit chooses. You must have properly maintained and used the product or part claimed to be defective in accordance with the maintenance schedule or manual, which comes with the product. No allowance will be made for labor, installation, removal, transportation or other charges incurred by you in connection with such repair or replacement.
- To obtain the above remedy:
 - A. Immediately notify the G-R Unit upon discovery of the claimed defect in materials or workmanship and provide the serial number or date code of the product and/or part(s) or provide the G-R Unit with the invoice or bill of sale referencing the product by no later than the expiration date of the warranty period.
 - B. The G-R Unit will advise whether inspection will be necessary and how whether repair or replacement will be made. If inspection by the G-R Unit is necessary, the pump or defective part must be sent freight pre-paid to the G-R Unit. Return shipment will be F.O.B. the G-R Unit's plant.
 - C. Return Goods Authorization Requirement: No product will be accepted for return or replacement without the prior written authorization of the G-R Unit. Upon such authorization, and in accordance with instructions from the G-R Unit, the product will be returned to the G-R Unit, shipping charges prepaid by the Buyer.
- 3. Damages: The G-R Unit's liability for damages for breach of this Limited Warranty shall not exceed the amount of the purchase price of the product or part(s) in respect to which Such damages are claimed. IN NO EVENT SHALL THE G-R UNITS BE LIABLE FOR INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES FOR BREACH OF THIS LIMITED WARRANTY.
